This letter is in response to your request dated July 3, 2014, pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552. Specifically, you requested the total amount of the Line of Credit Control System (LOCCS) balances for all Indian Housing Block Grants (IHBG) recipients as close as possible to January 1, 2014, to include the 5% of the balance against the last IHBG grant, a list of the tribes approved for investment and, if possible, investment amounts.

When responding to a FOIA request, the Department of Housing and Urban Development searched for responsive documents existing up to the date the request is received in the Department's FOIA Branch. Your request was received on February 3, 2014, and your clarified request was received on July 9, 2014.

Your request is granted in full at no cost. Enclosed is a copy of information you have requested. Investment amounts were not provided because HUD does not maintain agency records that contain tribal investment amounts.

For your information, your FOIA request, including your identity and any information made available, is releasable to the public under subsequent FOIA requests. In responding to requests, the Department does not release personal information, such as home address, telephone number, or Social Security number, all of which are protected from disclosure under FOIA Exemption 6.
