- 1 PROCEEDINGS
- 2 MR. DOLLARHIDE: Third time is perhaps the charm.
- 3 We're going to go ahead and get started for the day,
- 4 folks.
- 5 (Pause.)
- 6 MR. DOLLARHIDE: I want to thank everybody for
- 7 being here this morning. It looks like and sounds like
- 8 we're all very vibrant. So we should be able to get a
- 9 lot of things done today, very talkative. So it's a
- 10 good thing.
- I'd like to start by opening this up with a
- 12 prayer, and I've asked Mr. Edward Begay to give us that
- 13 blessing.
- 14 MR. BEGAY: (Speaking Native language.) Good
- 15 morning. It's a beautiful morning. I see that we all
- 16 got some rest so we could be ready for a new day of
- 17 work. And before we do, let us all bow in prayer.
- 18 (Speaking Native language.)
- 19 Merciful and kind, gracious, heavenly Father, we
- 20 approach your throne of grace this morning. We pray
- 21 for wisdom. We pray for your patience and love. And
- 22 also, Lord, we pray for traveling mercies for all the

- 1 committee members, pray for their families, pray for
- 2 those that have need of every things. Lord, be
- 3 gracious unto them.
- 4 And we pray for our soldiers in the warfronts.
- 5 Lord, watch over them and bring them back to us safely.
- 6 Guide us, O Lord, everlasting, for we are your
- 7 creatures, and we are all in your image. Therefore,
- 8 Lord, let us be kind to one another and forgive us our
- 9 shortcomings and bless us this day.
- 10 In Jesus' name, amen.
- 11 MS. BRYAN: Good morning, everyone. I would like
- 12 to just do some housekeeping. We have the protocols
- document ready to be signed. So I'm going to ask if we
- 14 can circulate that document. So if you see it come in
- 15 front of you, go ahead and sign it and pass it on.
- And then I have to apologize ahead of time. I'll
- 17 be leaving at 3:30 p.m. today to catch my flight, 3:30
- 18 p.m. or 4:00 p.m. And so, I'll just tell you that if
- 19 you don't see me later.
- 20 (Pause.)
- MS. BRYAN: So we have some great ideas and
- 22 suggestions and direction for today's work for the

- 1 workgroups, the products that we'd like you to bring
- 2 back today. In a little bit, we will break and come
- 3 back at 2:45 p.m. for our afternoon session.
- 4 We did want to ask if folks just spend a few
- 5 minutes -- we don't want to spend an hour or too much
- 6 time. But if folks who have been here before, for the
- 7 benefit of not only Jason and myself, but other new
- 8 members who are around the table who might have seen
- 9 some confusion yesterday, talk about the role of the
- 10 co-chairs and the role of the workgroups and what
- 11 you've done in the past that you think was successful.
- We just feel like that few minutes of time will be
- 13 beneficial to all of us. So we'll open up the floor,
- 14 please.
- 15 MR. DOLLARHIDE: Carol?
- 16 MS. GORE. Good morning. Carol Gore, and my
- 17 comrade Jason Adams is going to help me out if my
- 18 recollection is fuzzy.
- I really want to thank Annette and Jason for their
- 20 hard work yesterday. I think they did a great job.
- 21 We, in essence, threw them into the fire and said
- 22 figure it out.

- 1 So Jason and I had a conversation this morning and
- 2 thought maybe it would be helpful to share a little bit
- 3 more about our previous experiences. And my
- 4 observations yesterday were that we were sort of
- 5 walking between Robert's Rules and really unanimous
- 6 consent and the protocols.
- 7 So from my perspective, the co-chairs represent
- 8 the tribal representatives here. They are our
- 9 leadership for this meeting, and we ask them to guard
- 10 the protocols and the charter. I see that as their
- 11 role.
- I also don't think it's necessary for a proposal
- 13 to have a second to see the light of day. In practice,
- 14 what happens, at least how it's worked before, is folks
- 15 have been able to advance proposals. We've been able
- 16 to have pretty robust conversations about them, and
- 17 really, anyone at the table can call for a consensus.
- 18 If they call for a consensus and a member feels
- 19 they're not ready to vote, they can say I'm not ready
- 20 to vote yet. I have more questions. And so, it's
- 21 really more about making sure that we have adequate
- 22 discussion, and then as we as committee members here

- 1 can advance our ideas in an open way.
- 2 And I think that's really been the conversation
- 3 and not just this meeting, but the last meeting. So,
- 4 in practice, that's how we handled things.
- 5 On the workgroup side, at least my experience is
- 6 the workgroups might choose to work differently. They
- 7 may not work through unanimous consent, but they have a
- 8 duty to bring the opinions that came out of that
- 9 workgroup to this committee. The only decisionmaking
- 10 body is this committee.
- 11 Decisions are not made within the workgroups.
- 12 They are simply the place to advance ideas and maybe
- 13 even come up with appropriate language to propose. But
- 14 the open and free exchange of ideas in those workgroups
- is critical to get something that's worthy of committee
- 16 consideration.
- 17 So those are sort of the summary of my
- 18 experiences, and there are others here that have been
- 19 through negotiated rulemaking before. Karin, you were
- 20 here. Marty, Jason, Rusty. I think it would be --
- 21 this is intended to be helpful to the committee members
- 22 who have not been here before, not necessarily to

1 suggest that we must do it the same way.

- 2 So I hope that was helpful. Thank you.
- 3 MR. DOLLARHIDE: Yes, Mr. Adams?
- 4 MR. ADAMS: Jason Adams, Salish Kootenai. Well, I
- 5 really don't have much to add to that. Carol did a
- 6 very fine job, and Jack did a very fine job of raising
- 7 her. So --
- 8 (Laughter.)
- 9 MR. ADAMS: I just wanted to say that, yes, there
- 10 was a little bit of confusion I saw yesterday, and so I
- 11 think it's appropriate to have this discussion and just
- 12 make sure that we're headed in the right direction. I
- don't think it's necessarily right or wrong, as Carol
- 14 said. It's just, you know, how to streamline this
- 15 process and get everybody working on the same page.
- So I appreciate the discussion. You know, one
- 17 thing I did notice that changed was, you know, we're
- 18 not giving the thumbs up anymore. In the past, in all
- 19 the meetings we've had, I think that's been our manner
- 20 to vote, consensus is thumbs up or thumbs down.
- In reading the protocols, it does say an
- 22 expression of -- how does it say it, "expressed

- 1 objection." And I guess that's the thumbs down to me.
- 2 So I would still hope that we would do that. When
- 3 somebody calls for a consensus, thumbs up/thumbs down
- 4 kind of a vote.
- 5 But other than that, I think, you know, just
- 6 having this discussion, making sure that we call for
- 7 consensus, friendly amendments when somebody does
- 8 propose something, that's the conduct we've had in the
- 9 past, and it has worked.
- 10 That's all I have. Thank you.
- 11 MS. BRYAN: Thank you. Any other feedback?
- 12 (No response.)
- MS. BRYAN: Okay. We do have some ideas of our
- 14 own. So we will share those with you.
- I have been asking for expressed objection or lack
- of expressed objection per the protocol language. Can
- 17 I just see by thumbs up/thumbs down, do you want to go
- 18 with thumbs up? I mean, is there -- is that a request?
- 19 Because I think if that's easier for you guys to
- 20 see how people are doing things, we can ask for that.
- 21 It's really we're flexible, and we're just going to
- 22 pick a way to do it this morning, and we're going to

- 1 stick with it.
- 2 And it's not Robert's Rules. There will be no
- 3 first. There will be no second. We'll try to be
- 4 dutiful in calling for the question or if -- you know,
- 5 if you all see things, it's like time to call the
- 6 question, feel free to raise your hand and call the
- 7 question and help us out.
- 8 Is there anybody opposed to using thumbs up/thumbs
- 9 down?
- 10 (No response.)
- MS. BRYAN: Okay. So I think in the future when
- 12 we call for a vote, we'll go ahead and do thumbs
- 13 up/thumbs down as that's what we're used to. That's
- 14 what we've done in the past, and that worked. And it
- 15 seems like a reasonable method for voting.
- Okay. In terms of the workgroups, we -- yes, oh,
- 17 Earl?
- 18 MR. EVANS: Thank you, Madam Chair. Earl Evans,
- 19 Haliwa-Saponi Indian Tribe.
- 20 Since we're doing -- discuss the voting, the only
- 21 other thing that I think I would express just for the
- 22 record is if we could just make sure that after we vote

- on a proposal, we could just have the statement made
- 2 something to the effect of a consensus has been
- 3 determined or a consensus is declared, just so that we
- 4 have that accurate in the minutes that that would
- 5 reflect a consensus.
- 6 MS. BRYAN: Thank you.
- 7 Okay. So we had formed three workgroups
- 8 yesterday. Actually, we have a drafting group as well
- 9 But the active workgroups for today, what we would
- 10 like to do is request, and you guys make up your own
- 11 decision on how you do things in the workgroup. But if
- 12 people are bouncing around from one workgroup to the
- other, I think it would be advantageous if you use the
- 14 same method of decisionmaking in the workgroups.
- So I would ask the committee chair people to get
- 16 together and see if that works for you guys. I know
- 17 the protocols say that workgroups establish their own
- 18 method of doing business, but for those of us who --
- 19 there is only one of me. So I may attend all three
- 20 workgroups. It would just be easier if we're all using
- 21 one method.
- 22 The other thing we would like to do is have some -

- 1 have you develop your subgroups today. We've heard
- 2 from the people we met with this morning, the HUD
- 3 staff, that that's a reasonable expectation on day one.
- 4 You may even get in, depending on how big or small the
- 5 issues are, further than that. But if we could at a
- 6 minimum have each workgroup develop subgroups along
- 7 with defining what your target goal is for that group.
- 8 What is your group trying to accomplish?
- 9 So you can report that back at the end of the day,
- 10 as well as suggest -- we would like to suggest, and
- 11 this is each workgroup, again, does it with their own
- 12 process. But if you go by the regulation, it might be
- 13 an easier way to do it. Those of you who have been
- 14 here before will be in the workgroups, and you'll know
- 15 what's the best, most efficient way to streamline this
- 16 work, but possibly perhaps going through the regulatory
- 17 language, seeing what -- if something is I think we
- 18 heard it yesterday, if it's not broke, why are you
- 19 going to try to fix it?
- 20 So looking at it, seeing if it's something that
- 21 needs to be changed or not, and then moving on from
- 22 there. Just as a suggestion.

1 And then we would like each workgroup also to come

- 2 up with what your expectations and needs are from HUD
- 3 staff. So at the end of the day, we want you to come
- 4 up with what you need from HUD -- technical assistance.
- 5 I don't know if data runs may come out of today or
- 6 however that works. But then HUD can be working on
- 7 those things between this meeting and the next.
- 8 Is there any questions? Sharon?
- 9 MS. VOGEL: Yes, I would like the floor for Mr.
- 10 Heisterkamp, please.
- MR. HEISTERKAMP: With the committee's indulgence,
- 12 since we were talking about the roles of the various
- 13 groups and how things have worked in the past, there is
- 14 a number of tribal support staff here, too, that has
- 15 been integral to this process. And many of them have
- 16 signed up again to be on the drafting workgroup.
- 17 As you know, in the protocols, we've set some
- 18 slightly different parameters than we've had in the
- 19 past for the drafting workgroup, and maybe for the
- 20 benefit of everybody to understand how some of us
- 21 perceive that group working to support, I'd just put a
- 22 few things out.

1 Generally, the drafting workgroup is really the technicians on the language, but I think it's more 2 appropriate and more efficient if the workgroups 3 themselves develop the language. It shouldn't be a 4 5 process where you bring a concept to the loosely 6 organized group and say somebody write a regulation that looks like this. So I would request that the 7 8 workgroups try and get the language together in the 9 workgroups. 10 There are going to be members of the drafting committee from the tribal legal and other support 11 staffs in every workgroup and every subgroup. So you 12 will have that assistance if you need that, but it 13 14 shouldn't be thought that generally the drafting group doesn't have a set time to meet. Unless the committee 15 asks it to discuss something, it's not going to be able 16 to review every idea every day. 17 Remember, these are just people that are 18 participating in all of these meetings. So if you do, 19 20 if the committee does want the drafting group to consider something, please consider giving some time 21 22 during the regular workday so those people can break

- 1 from the sub-workgroups, meet. It usually doesn't take
- 2 very long. This is not a group that's going to make
- 3 any decisions, that's going to make any proposals on
- 4 its own. It really is the back-up technicians.
- 5 But don't meet for 12 hours a day and expect to
- 6 have something at 7:00 the next morning out of that
- 7 group because we've all been through the same. Just a
- 8 consideration. So we're going to try and get the work
- 9 done as members of the various workgroups. Generally,
- 10 we'll distribute ourselves among the workgroups and the
- 11 sub-workgroups and get the language drafted there.
- 12 Okay?
- 13 There's no -- there's been some confusion in the
- 14 past. Sometimes people want to send something off to
- 15 the drafting group, get language back, and then have a
- 16 back and forth. That has proved not to be a very
- 17 efficient way for operation.
- 18 So the people I have discussed it with, we're
- 19 going to try and do our job inside the group. There
- 20 may be some other times we want to meet and talk about
- 21 the preamble. And again, remember, this is an ad hoc
- 22 group. Just because your name is on that list or not

- 1 on the list, everybody gets to participate whenever
- 2 they want, the more the better.
- 3 So just to finish out that role where that
- 4 workgroup fits in the committee's work.
- 5 MS. BRYAN: Great. Thank you, David. Thank you,
- 6 Sharon.
- 7 I would just also go back to the protocol. If --
- 8 I would hope that you are able to get the language done
- 9 in the workgroups, but it looks like if someone is in a
- 10 workgroup that doesn't have a legal counsel, that they
- 11 can refer it to the drafting group for that support.
- 12 MR. HEISTERKAMP: I would suggest -- I'm sorry. I
- 13 would suggest that in the rare instance you find
- 14 yourself without tribal legal support in one of the
- 15 groups, that you at least try to get some words down on
- 16 paper if there's something that needs to be changed.
- 17 But generally, the groups know best how they want
- 18 things to read.
- 19 If there's something, you know, terribly out of
- 20 whack or could be done better, I'm sure that the
- 21 members of the drafting group will try to help with
- 22 that. But please don't just bring an idea or a verbal

- 1 comment to the group because we won't be able to know
- 2 what the workgroup did or what they exactly want.
- 3 So even if you don't -- in the rare instance you
- 4 don't have a tribal attorney available to help you with
- 5 that, please try and get something on paper before you
- 6 bring it to the drafting workgroup so we know what the
- 7 will of the workgroup is.
- 8 MS. BRYAN: Noted. Thank you.
- 9 Are there other questions or comments before we
- 10 start our work?
- 11 MR. DOLLARHIDE: Mr. Evans.
- 12 MS. BRYAN: Oh, excuse me. Mr. Evans and then Ms.
- 13 Henriquez.
- 14 MR. EVANS: Thank you, Madam Chair.
- 15 Earl Evans, Haliwa-Saponi Indian Tribe. One other
- 16 suggestion that kind of goes along with what you
- 17 stated, Madam Chair, if I'm in order to make such a
- 18 recommendation, is one of the things that we also had
- in reference to the drafting committee the last time
- 20 around was we had a lead tribal drafter and a lead HUD
- 21 drafter. And I would like to request, if possible,
- 22 that at some point in time the drafting committee get

- 1 together and determine those individuals because it
- 2 might make it easier for those individuals to
- 3 coordinate whatever it is, whatever the expectations
- 4 are that the drafting committee has for them if they
- 5 know that they have that responsibility on the front
- 6 end, as opposed to them having it on the back end.
- 7 Because I think at the end of the day, the last
- 8 round we had, we kind of relied on those folks to kind
- 9 of do the final look-see to make sure everything said
- 10 what it was supposed to say and every "i" was dotted
- 11 and every "t" was crossed. And I think if we go ahead
- 12 and have those from the beginning, you know, we could
- 13 kind of have that additional cross-checking going on.
- Just a suggestion, Madam Chair.
- MS. BRYAN: Thank you. Ms. Henriquez?
- 16 MS. HENRIQUEZ: Good morning. Thank you.
- I just wanted to offer on behalf of HUD, there may
- 18 be other information, other reports, sets of data that
- 19 members of the committee might want. For example,
- 20 we're going to pass out the American Community Survey
- 21 that was talked about yesterday so that you can see
- 22 exactly what this multiple-page questionnaire might

- 1 help you think in your committee work about other
- 2 things that you might want to check, other
- 3 conversations you might want to have, other data and
- 4 datasets you might want to do beyond just formula runs.
- 5 And so, if you would make us aware of what you
- 6 want, we will collect that information, put it
- 7 together, and disseminate it to every member of the
- 8 committee, not just the people or the groups of people
- 9 that ask for it. So we've all got the same foundation
- 10 of information moving forward.
- And if the committee comes at the end of today or
- 12 the workgroups with lists of stuff that you'd like to
- 13 start us compiling, we can do that as well, and we'll
- 14 start our work that way.
- 15 MS. BRYAN: Thank you, Sandra. Mr. Cooper and
- 16 then Ms. Gore.
- 17 MR. COOPER: And just since Sandra brought it up
- 18 and offered some assistance, yesterday we had some
- 19 discussion about the HEARTH Act and different
- 20 variations. I was wondering if maybe at some point in
- 21 time, maybe some of the HUD staff could maybe prepare,
- 22 you know, a white paper or just some type of summary

- 1 maybe on that. That might be helpful to the committee
- 2 members.
- Because I know that that did come up yesterday,
- 4 and there was discussion about there is two separate
- 5 acts and just some stuff like that. I think that would
- 6 probably come in -- would be helpful sometime during
- 7 our conversation.
- 8 MS. BRYAN: Great suggestion. Ms. Gore?
- 9 MS. GORE: Thank you. Carol Gore.
- 10 So I recognize the value of the time we have in
- 11 our workgroups and also in the committee, but one of
- 12 the other values is a regional caucus, and Alaska is
- 13 asking for a caucus immediately following lunch today.
- 14 At the will of the committee, we wanted to have at
- 15 least 30 minutes.
- 16 And I don't know how that has to divide the work,
- 17 but many people are getting on planes to try to get
- 18 back home. So we're trying to capture our members
- 19 while we're here and share ideas and share outcomes
- 20 from the workgroups. So Alaska is requesting a caucus
- 21 to start at 1:15 p.m., a minimum of 30 minutes, and I
- 22 don't know if others share that desire.

- 1 Thank you.
- 2 MS. BRYAN: Thank you. I'll recognize that
- 3 caucus. I will -- then the agenda will read we'll
- 4 break into our workgroups, go to lunch, and then
- 5 immediately following lunch go into your caucus.
- 6 So each caucus will meet at 1:15 p.m. to 1:45 p.m.
- 7 And then the schedule shows us continuing in our
- 8 workgroups and coming back here at 2:45 p.m. So that
- 9 will be the agenda for this day.
- 10 Any other questions or comments?
- 11 (No response.)
- MS. BRYAN: Okay. We're ready to work. So thank
- 13 you all for your helpful words this morning, and I wish
- 14 you all good energy when you go and do the hard work
- 15 that we're about to go do.
- 16 You're dismissed.
- MS. FIALA: Do you want to have room assignments?
- 18 MS. BRYAN: I'm sorry. I knew I would forget
- 19 that. May I please have a -- for room purposes, we
- 20 have rooms available to us that have different seating.
- 21 May I see a show of hands for people in each
- 22 workgroup? So if I call the workgroup and you think

Page 23 1 you might be in, knowing that you can change, that that may change. But who plans on attending the needs 2 3 workgroup today? Can I see a show of hands, please? (Show of hands.) 4 5 MS. BRYAN: Thank you. FCAS workgroup, show of 6 hands. 7 (Show of hands.) 8 MS. BRYAN: Thank you. Other topics workgroup? 9 (No response.) 10 (Laughter.) MALE SPEAKER: I'll go. 11 12 (Laughter.) 13 MS. BRYAN: So we'll just -- we'll have a room 14 available should those -- I think the other topics are going to flesh themselves out as we work through the 15 16 two major workgroups. So we'll have a room available if people should have that need. 17 18 Thank you. Now Sara will announce which rooms are which. Lafe, are you going to be in the other topic 19 20 workgroup? 21 MR. HAUGEN: No, I was going to say if he's the 22 only guy, can we just use a closet instead of a room?

- 1 (Laughter.)
- MS. FIALA: The needs group is going to be in
- 3 Maroon Peak, where the FCAS group was yesterday.
- 4 Maroon Peak is right across the hallway.
- 5 And then the FCAS group will be up in Mount
- 6 Wilson, which is on the third floor. Just take the
- 7 escalators up. And then the other group of one will be
- 8 Mount Harvard, which is also upstairs on the third
- 9 floor.
- 10 MS. BRYAN: Now we are dismissed. Thank you.
- 11 (Break.)
- MR. DOLLARHIDE: We're going to go ahead and call
- 13 the meeting to order at 3:11 p.m. So if everybody
- 14 could be seated, please? Thank you.
- MR. NICHOLS: Okay. Welcome back, everybody. I
- 16 hope you had productive time in your workgroups and
- 17 caucuses.
- 18 And the first order of business that we'd like to
- 19 conduct as we enter the home stretch here of the
- 20 meeting is we want to make sure that the committee has
- 21 co-chairs in place for the next meeting. So the
- 22 protocols call for selection of the co-chairs for the

- 1 next meeting at the conclusion of this meeting. So
- 2 we'd like to do that first.
- 3 So I would open it up for discussion or
- 4 nominations. Yes, Mr. Jacobs?
- 5 MR. JACOBS: Leon Jacobs, Lumbee Tribe. I
- 6 recommend that we keep the two that we have.
- 7 MR. NICHOLS: Okay. So the proposal that's made
- 8 is that we keep the two co-chairs that we have today.
- 9 Is there any discussion on that before we call the
- 10 question?
- 11 (No response.)
- MR. NICHOLS: Okay. Then let's call the question,
- and by the agreement of the committee, we'll do the
- 14 thumbs up or thumbs down.
- 15 (Voting.)
- 16 MR. NICHOLS: And I see unanimous consensus on
- 17 that. So that question is settled by unanimous
- 18 agreement that the co-chairs we have today will
- 19 continue for future meetings. Thank you very much for
- 20 that.
- 21 And the next item that we -- housekeeping item
- 22 that we wanted to cover briefly with you is there have

- 1 been a lot of requests for the ACS data, the American
- 2 Community Survey data. HUD is still in the midst of
- 3 processing that data and analyzing it, compiling it.
- 4 So the committee chairs have requested that each
- 5 committee member receive that data from HUD as soon as
- 6 it is available, and HUD has agreed to that.
- 7 It will probably be in the December timeframe, but
- 8 we wanted you to know that that data will be
- 9 forthcoming to you in that timeframe.
- 10 So, with that, I will turn it over to the co-
- 11 chairs to continue the rest of the business of the
- 12 committee. Thank you.
- MS. BRYAN: Thank you, Steve.
- 14 And also just not to have a huge discussion about
- 15 this, but the ACS has been handed out to each of us. I
- 16 would really appreciate it if you could email Jason and
- 17 myself about right now they're collecting variables
- 18 that are in the 2000 census. So it's going to be
- 19 apples to apples.
- 20 If there's variables in this survey that you would
- 21 like to see, please let us know, and that can be part
- 22 of our request. We do have some time. I think we

- 1 should be looking at all the variables, but Jason and I
- 2 will be following up with Jackie at HUD and really try
- 3 to get data that's meaningful to you guys to inform the
- 4 work that you're doing in your workgroups. So that's
- 5 good order of business.
- 6 The next order of business is document control,
- 7 and I was going to have Sara walk through how we're
- 8 going to get documents to you all. And I think within
- 9 the workgroups when you report out, you'll let us know
- 10 what your procedure is in-house for getting information
- 11 either from your subgroup back to your workgroup and
- 12 ready to prepare to the full committee.
- We do have numbering systems. There's a document
- 14 that's been drafted -- Are we prepared to hand that
- 15 out? -- for data request forms.
- Jason and I have thought long and hard and we put
- 17 our best judgment together, and our proposal to this
- 18 committee is that we go through the co-chairs for data
- 19 requests. The reason for that is efficiency so that if
- 20 one committee is asking for five datasets that the
- 21 other committee is asking for, we're not duplicating
- 22 our efforts.

- 1 Or if five members have the same question, each
- 2 member can just go and ask, which is fine. You can ask
- 3 your co-chair. And if that's okay with the chairs of
- 4 the committee or the co-chairs of the workgroup
- 5 committees, we would like to ask that the requests are
- 6 approved by the workgroup chair people. And that's the
- 7 document you see in front of you.
- 8 Yes, Ms. Gore?
- 9 MS. GORE: Just a couple of questions about that
- 10 process. So understanding that our two co-chairs
- 11 already have full-time jobs, I'm wondering about
- 12 turnaround time. If we're making our requests through
- 13 the co-chairs, your commitment to the committee -- did
- 14 I understand that right?
- MS. BRYAN: Through the workgroup chair people.
- 16 So that's even a bigger question for you, Carol, as the
- 17 co-chair of your workgroup.
- MS. GORE: Well, I'm a co-co-chair. So I'm not
- 19 sure that fits.
- 20 (Laughter.)
- 21 MS. GORE: So I guess my next question is, hmm. I
- 22 understand the intent. I'm just not sure that we will

- 1 always catch duplication since there are two co-chairs,
- 2 and they would have to be working together. So I guess
- 3 what I would also suggest is that HUD provide support
- 4 to those co-chairs in the case they identify
- 5 duplications so that, you know, the recipients or the
- 6 requesters of those reports would know that their needs
- 7 are getting met, but it was a duplicate request.
- 8 That's all I'm suggesting, that there be a second
- 9 back-up to that. Thank you.
- 10 MS. BRYAN: Thank you. I see Sharon and Earl.
- 11 MS. VOGEL: Could I have a clarification on the
- 12 requesting data? Now did I understand that it was
- 13 going to be -- if you requested data, it was going to
- 14 be the entire dataset for every recipient and not just
- 15 yours. Correct?
- MS. BRYAN: I think that's what a dataset is. Is
- 17 that right, HUD? They're shaking their heads yes,
- 18 Sharon.
- 19 MS. VOGEL: Okay.
- MS. BRYAN: Earl?
- 21 MR. EVANS: Earl Evans, Haliwa-Saponi Indian
- 22 Tribe. The only issue, I guess I have more of a

1 question or a request for clarification. You said that

- these requests, when they're turned into the co-chairs,
- 3 had to be approved by the co-chairs. And I think
- 4 somewhere we already said that any committee member can
- 5 request information, and I think that goes against the
- 6 established protocols, unless I'm mistaken, for a co-
- 7 chair to have to approve a request submitted by a
- 8 committee member.
- 9 So I don't know if when you said "approved" that
- 10 you meant that the committee chair can deny the
- 11 request, or did you mean it's simply for purposes of
- 12 facilitation? Because if it's the latter rather than
- 13 the former, then my suggestion would be to allow the
- 14 facilitators to be the recipients of the request and
- 15 simply determine whether there is duplication.
- And where there is, maybe they could verify with
- 17 HUD that these two things, these three requests or
- 18 whatever are asking for the same thing and kind of come
- 19 up with one response to those three requests, if that
- 20 makes any sense.
- That's my suggestion, Madam Chair.
- MS. BRYAN: I'm going to let Sandra speak because

- 1 I think she's going to say what I think I was going to
- 2 say.
- 3 MS. HENRIQUEZ: The -- thank you. The contract
- 4 for facilitation does not include that role. That
- 5 would be an additional cost, and it would be adding to
- 6 a contract that would really mess up our procurement.
- 7 So that probably should be off the table. Sorry.
- 8 MS. BRYAN: Jason?
- 9 MR. ADAMS: It's not -- Jason Adams, Salish
- 10 Kootenai. It's not that I don't disagree with what
- 11 you're attempting to do here, but I do agree with Earl
- 12 that this is in conflict with our approved protocols
- 13 now.
- And so, the other thing I think could happen is
- 15 why can't in following the protocol, when somebody
- 16 submits this, if HUD is receiving these, then HUD can
- 17 determine that it isn't the same as this one so that
- 18 it's not duplicated. And it seems like that they could
- 19 be the gatekeeper on this, just to determine that two
- 20 requests are the same.
- 21 MS. BRYAN: And is it in the charter, if maybe not
- the protocols somewhere?

- 1 MR. ADAMS No, it's in the protocols under
- 2 Safeguards for Committee Members, (e) HUD Assistance to
- 3 Committee Members.
- 4 MR. NICHOLS: Section 6(e).
- 5 MS. BRYAN: Thank you. Because I do remember that
- 6 we did talk about this, and we wanted all committee
- 7 members to have, you know, the information that they
- 8 needed. So our only, you know, proposal was to keep
- 9 the information streamlined.
- 10 My understanding from HUD is when they get a data
- 11 request, they really forward it on. So if five people
- 12 ask for the same thing, they're not monitoring it.
- 13 They're just forwarding and processing it.
- 14 Heather and then Karin and then Sharon.
- 15 MR. DOLLARHIDE: Can I -- let me --
- 16 MS. CLOUD: Heather Cloud, Ho-Chunk Nation. Would
- 17 you -- would it be okay if on this bar, you just took
- 18 off the second box where it's the date request is
- 19 submitted to workgroup chairperson or workgroup
- 20 chairperson name/signature? Because you're just
- 21 submitting it to HUD, and I think if HUD already ran
- 22 information, they would still have that information,

- 1 right? It's not like that they'd have to keep running
- 2 it?
- 3 MS. FOSTER: Karin Foster. My comment, actually,
- 4 is related to what Heather just said, and that is if
- 5 you get -- if HUD gets five requests and they're
- 6 identical, then it's no harder -- I mean, they're doing
- 7 the same work to answer each request.
- 8 So if they get requests that they think are very
- 9 similar, I guess that's something else, but they
- 10 shouldn't be able to reject one over the other in that
- 11 case. But if they're exact, then it shouldn't be an
- 12 issue.
- I also do think that it is important for every
- 14 committee member to be able to submit a request. That
- 15 was one of the issues I was concerned about. But I
- 16 didn't hear you say that the workgroup chairperson
- 17 would be approving, and maybe I just didn't hear the
- 18 language you used. I thought you said "submitted
- 19 through," which sounded to me to be an administrative
- 20 thing.
- 21 But I don't have, you know, a view one way or the
- 22 other. As long as nobody else has the ability to

- 1 approve a request before it clears.
- 2 MR. DOLLARHIDE: Yes, you are correct in saying
- 3 that. There really isn't -- there is not an approval
- 4 process. We're looking more from a, I guess for lack
- of better word, redundancy process so that we're not
- 6 getting several same requests.
- 7 I understand that Jason and Carol and Sami Jo do
- 8 have a full-time job, and you know, I do respect that.
- 9 I do believe that, you know, we all are very busy
- 10 around the table. I also understand that that is a
- 11 little extra, and also I wouldn't expect same-day
- 12 turnaround on those requests from those individuals.
- 13 So --
- 14 FEMALE SPEAKER: I think "approval" is the wrong
- 15 word.
- MR. DOLLARHIDE: Well, yes, "approval" was the
- 17 wrong word, Earl. You know, those requests just go
- 18 through those folks. So that's kind of -- that's what
- 19 I was trying to say.
- 20 MS. BRYAN: Sharon?
- 21 MS. VOGEL: Sharon Vogel, Cheyenne River. If
- these are going to be posted on the Web site, then that

- 1 would be very helpful because then I could go and look,
- 2 you know, on Friday and see what's all been requested
- 3 that week. And then I would know that I'm going to be
- 4 receiving that already. So I think that would also be
- 5 another mechanism to help you to control the requests.
- 6 Thank you.
- 7 MS. BRYAN: Thank you, Sharon. We'll have a Web
- 8 site demonstration for everybody to look at before we
- 9 leave here today so that you'll see how to get that
- 10 data, and that's a very good point. We should all be
- 11 checking it regularly.
- 12 Jason?
- MR. ADAMS: Well, I just wanted to add to that
- 14 same point that there is -- you already brought it up
- 15 briefly about document control. There is going to be
- 16 documents that somebody is taking a look at and putting
- 17 a control on. And so, in previous NegRegs, if one of
- 18 these was submitted, if I remember correctly, that
- 19 somebody had asked for something, HUD could respond and
- 20 just say this is document such-and-such already and put
- 21 it right on the document, give it back. Say this
- 22 already exists.

- 1 That's what's been done previously. So I really
- 2 think you're making an issue here that really doesn't
- 3 have to be. And yeah, I do have a full-time day job,
- 4 and if you want me to do this, I'll submit my contract.
- 5 (Laughter.)
- 6 MS. BRYAN: So what I'd like to offer is I do
- 7 appreciate the feedback. It's really, really useful,
- 8 and our ideas, like I say, we're new. We haven't been
- 9 around the table before. We thought it was a really
- 10 good idea, but the alternative is to take off Box
- 11 Number 2, and that would be the proposal document that
- 12 we use.
- 13 Other comments? Heather?
- 14 MS. CLOUD: I'm not really sure if we need to have
- 15 your workgroup because what if the request that
- 16 committee member is submitting not related to a
- 17 workgroup? I know we have the other and drafting. I
- 18 mean, if you're looking for information.
- I'll go with what the group says, but I don't know
- 20 if we really need your workgroup on there.
- 21 MS. BRYAN: So I have a question for the group.
- 22 Was that on the last form? This is a draft that we

,

- 1 used the last form for a template. So was that on the
- 2 last form? Sara believes that the workgroup was on the
- 3 last form. Do you guys recall? Jason?
- 4 MR. ADAMS: They showed one the other day.
- 5 MALE SPEAKER: Yes, it was.
- 6 MS. BRYAN: It was. So we're just using what's
- 7 been used in the past. I'm with you, Heather. I'm
- 8 flexible.
- 9 Karin?
- 10 MS. FOSTER: Karin Foster. I agree with Heather.
- I think that, you know, we won't always be in exactly
- 12 the same workgroups either. I mean, there may be times
- when we want to go over to the other group, and there
- 14 may be questions that we have that are related to
- issues that are coming before the full committee and
- 16 aren't necessarily one workgroup or the other.
- So I don't know that they need to be identified
- 18 that way. I can see the utility of including the
- 19 workgroup if we're actually submitting it through the
- 20 workgroup chairperson. But if we're not, then I don't
- 21 see the utility for including it.
- 22 MS. BRYAN: Thank you. Excellent comments.

Denver, CO

- 1 So can we strike "your workgroup"? Any other
- 2 comments before we move on?
- 3 (No response.)
- 4 MS. BRYAN: Okay. This document has been amended.
- 5 It is in draft form. We will have the original
- 6 printed. Just a point of order for you folks to help
- 7 me out here. Is this something that we need to
- 8 approve?
- 9 I see heads shaking up and down. So since we'll
- 10 just -- this is the document we're going to use, and
- 11 we're going to move forward from that topic. And thank
- 12 you for your good input.
- MS. HENRIQUEZ: Excuse me. Point of
- 14 clarification.
- MS. BRYAN: Yes, ma'am?
- 16 MS. HENRIQUEZ: I want to make sure I got this
- 17 straight so we don't screw up. So this form, this
- 18 amended form is going to get filled out as a data
- 19 request or information or a report request or whatever
- 20 you're looking for. It will get posted on the Web site
- 21 -- before that. I'm ahead of myself.
- To whom does it get filled out and then goes to

- 1 whom or where? To HUD. All right. So we're going to
- 2 want to now maybe identify the HUD person point of
- 3 contact, and maybe we should amend the form to put it
- 4 right on there as well, both by name, phone number, a
- 5 mailing address, and an email, so that there's no
- 6 mistake.
- 7 Because if we're going to be in charge, we want to
- 8 make sure that we are responsible to all of you for
- 9 making sure it's in and out. All right? So let us --
- 10 let's -- I'm just going to go talk to someone for a
- 11 minute, and I don't even know who this is. But then
- 12 we'll get the information put on the form.
- Okay. Thank you.
- MS. BRYAN: Very, very good ideas. So while she's
- 15 doing that, I'm going to make an announcement about
- 16 other things that I'm told that HUD can provide to us.
- 17 So we will be having as part of our process and our
- 18 regular working committee process regular conference
- 19 calls. That's a given and part of what's already been
- 20 established.
- 21 What HUD has offered, in the absence of a budget,
- 22 is that we can have live meetings. They've offered

- 1 Skype if we're technically able to do that. They could
- 2 provide note takers. They could provide conference
- 3 calls that we can all dial into where they would have
- 4 note takers available.
- 5 And these are just for the workgroups and the sub-
- 6 workgroups because under the open meeting rules, if we
- 7 have a full committee meeting, which isn't unheard of,
- 8 if we all want to pay for it ourselves, HUD could
- 9 provide technical assistance for that. But we have to
- 10 publish it in the Federal Register.
- So for now they're offering for the workgroups and
- 12 subgroups note takers and also regional office space.
- 13 So if a group, a subgroup is able to get together, they
- 14 could provide -- in Denver or Seattle or some other
- 15 area, they could provide office space, note takers,
- 16 technical assistance, and also conference lines if
- 17 people want to call in. It would be at your own
- 18 expense at this time until they get a budget.
- 19 Are there any questions for HUD about these
- 20 offers? Karin?
- 21 MS. FOSTER: Then would the information that
- 22 included call-ins or being able to get on mailing lists

- 1 or whatever all needed to be done, would that all be
- 2 available to everyone on the IHBG site so that the
- 3 public can participate?
- 4 MS. BRYAN: Yes, that's a very good guestion, and
- 5 HUD did offer that, too. It's actually part of the
- 6 regulation that they have to follow that they will
- 7 publish -- make that information available to everyone,
- 8 and we'll request that it goes up on the Web site that
- 9 Sara is going to show us.
- 10 Other questions for HUD or about that
- 11 announcement?
- 12 MR. DOLLARHIDE: Carol. Carol.
- 13 MS. BRYAN: Carol?
- MS. GORE: Yes, I just have one question, and that
- is I really enjoyed having the workgroups open to the
- 16 public, and so I'm just wondering how we will announce
- 17 those meetings so that people can attend? That's my
- 18 only question. So that we're as inclusive as we've
- 19 tried to be here during our negotiated rulemaking
- 20 meetings.
- 21 Thank you.
- MR. DOLLARHIDE: Those announcements would be put

- 1 on the Web site. We would have to give HUD ample
- 2 opportunity within -- under the open meetings law to
- 3 make that announcement of those conference calls, et
- 4 cetera, et cetera. And they would all be posted for
- 5 everybody to see. Everybody would be welcome to call
- 6 in, not only just the workgroup or the sub-workgroup,
- 7 but all public also.
- 8 MS. BRYAN: Yes, Rusty?
- 9 MR. SOSSAMON: As a matter of notification, could
- 10 there also be a direct email list that we could sign up
- 11 for so that as it's posted on the site, we're notified
- 12 by email as well?
- MS. BRYAN: There is a request to have an email
- 14 list set up so that when these meetings are put
- 15 together that the whole group can be notified, and I'm
- 16 getting a thumbs up. Good request.
- 17 Karin?
- 18 MS. FOSTER: Karin Foster. I just had a comment.
- 19 I think this is great to have an opportunity to be
- 20 able to continue our work, particularly in view of the
- 21 uncertainties of funding. But I really do think that
- 22 having people in the same room in the workgroups is a

- 1 better way to go, and I really don't want to see us go
- 2 to a process where, you know, we feel like that's a
- 3 substitute for being in the same room.
- 4 Because I don't think it is. I think it's a
- 5 stopgap measure maybe, but I don't want it to be viewed
- 6 as adequate.
- 7 MR. DOLLARHIDE: You know, it's for discussion
- 8 only. You know, by no means are they requesting that
- 9 we do that. It's just something that they will make
- 10 available to us if it's so desired by this committee
- 11 and the workgroups and the sub-workgroups if there is
- 12 momentum built, you know, to keep that momentum going.
- 13 If that's what is so desired of the chairs of those
- 14 committees, then HUD has graciously made that available
- 15 to us. By no means do we have to accept it.
- 16 MS. BRYAN: Sandra, were we waiting on something
- 17 from you?
- 18 MS. HENRIQUEZ: They're putting -- I think it's
- 19 going up.
- MS. BRYAN: Glenda is going to be our contact?
- MS. HENRIQUEZ: Correct.
- MS. BRYAN: And you can wave, Glenda?

- 1 MS. HENRIQUEZ: Oh, I'm sorry. Glenda? Do you
- 2 want to stand up and wave?
- 3 MS. BRYAN: In the back corner. Thank you.
- 4 All right. So now we have -- we'd like to -- yes,
- 5 Jason?
- 6 MR. ADAMS: Real quick. Jason Adams, Salish
- 7 Kootenai. Before you move past this issue on this
- 8 proposal for communicating or whatever we want to call
- 9 it between now and our next meeting, I guess I'm a
- 10 little concerned on trying to decide right now whether
- 11 we do that or not because I want to bring that issue
- 12 back to my workgroup and let them decide. And I don't
- 13 have any time on the agenda to go back. So it's really
- 14 a tough thing to try and say yes or no to.
- We agreed amongst ourselves that we were going to
- 16 -- we have an email address thing set up, and we're
- 17 going to, you know, share some data that way just
- 18 through email so everybody, you know, if they have
- 19 issues or discussion that way. But I just think this
- 20 came too late. Sorry.
- 21 MR. DOLLARHIDE: It was just an offer, Jason.
- 22 It's not something that we need to make a decision on

- 1 today. All that HUD requested was that we give them
- 2 ample time to make notice according to the open
- 3 meetings law, and then they could make that happen for
- 4 us at our -- you know, at our leisure.
- I mean, if you want to discuss that with your
- 6 workgroup in email, however that you want to do that,
- 7 you know, and make that decision, then we can -- we
- 8 can, you can relay that message to HUD, and they will
- 9 get that process going to make not only the committee
- 10 members, but also the public aware that you will have a
- 11 conference call or something concerning your committee.
- 12 MS. BRYAN: Karin?
- MS. FOSTER: Karin Foster. Can I just suggest
- 14 that, you know, we are in such an uncertain time right
- 15 now in terms of what the budget is going to look like
- 16 that maybe more use of this offer would be something we
- 17 could consider, you know, a little later on once we
- 18 know where we are and how long is it going to be before
- 19 we can really meet?
- 20 Maybe the committee could conference on that, and
- 21 we could think about it a little bit. What is
- 22 conducive to doing this way, what business can we

- 1 advance? I don't know. Maybe that sounds too
- 2 complicated, but I'm just thinking right now my feeling
- 3 is that I'd like to have more in-person business
- 4 transaction, more in person, not, you know, remotely.
- 5 But if we're not going to be able to meet for 6
- 6 months, then I might change my view.
- 7 MR. DOLLARHIDE: And that's fine. It was just an
- 8 offer to throw out to the committee. It's nothing that
- 9 we have to turn down or accept today. So we'll move on
- 10 to the next housekeeping.
- MS. HENRIQUEZ: Excuse me. Would it be helpful if
- 12 we talked a little bit about what we know or how little
- 13 we do know about the Federal budget landscape in this
- 14 context, if that's the committee's pleasure? Or I car
- 15 do it, say, with your closing remarks.
- 16 MS. BRYAN: Thank you, Sandra. I think if we do
- 17 it at closing remarks, it might be a more efficient use
- 18 of our time we have left. We did want to just quickly
- 19 show you all where the information is that we've had
- 20 thus far.
- 21 The protocols are on there, our charter, many of
- 22 you probably already have checked into this Web site.

- 1 There's a member portal where we sign in. They are
- 2 working on some -- we called it "cloud" earlier, but
- 3 they're working on some ways to get information to us
- 4 in real time. So that is coming, if it's available,
- 5 and we'll tell you more about it later. If it -- you
- 6 know, they're working on it.
- 7 So, Sara, if you want to just run us through it
- 8 very quickly, and then we'll get on with our reports.
- 9 Thank you.
- 10 MS. FIALA: Hi, everyone. I'll just go through
- 11 this really quickly. I know I did a brief tutorial
- 12 last session, but I think most of the questions have
- 13 been about documents. So I'm just going to run through
- 14 that portion.
- For the general public who are not committee
- 16 members, as soon as documents are finalized at the
- 17 committee, we will begin to post them under this tab
- 18 right here called Documents. So as you can see, I have
- 19 not gotten a chance to post yet the documents that were
- 20 finalized at this meeting, but you can see some of the
- 21 documents that we had up on the last -- sorry. I don't
- 22 know what that is. Sorry.

- 1 From the last meeting. So you can see the final
- 2 agenda, the approved charter. Then the transcripts are
- 3 up there from the last session as well.
- 4 For the members, you should all have your member
- 5 log-ins now, and Gail said it, if you have any problems
- 6 with that and you have not been to authenticate your
- 7 account, just please feel free to call me, and I can
- 8 walk you through and make sure that you are set up.
- 9 So some of the options that we've been working on
- 10 to try and get information out to the committee
- 11 members, we're going to be doing some changes and doing
- 12 some internal discussion and figuring out a way to do
- 13 quicker posting of materials to the Member section. So
- 14 you can see we have some travel and logistics. We have
- 15 member documents right now.
- 16 So for this meeting, we have some of these, and
- 17 you can see we posted up the draft agenda. So we'll
- 18 begin posting that information into the Member section
- 19 that you'll need, and then also once they're finalized,
- 20 again, they'll get transferred over to the general
- 21 public section.
- 22 Some of the options that we do have for the

- 1 workgroups, and again, we can have some conversations
- 2 about this. I know we're short on time. But something
- 3 we can do are add more tabs down into this member
- 4 document. So we could add another tab for, let's say,
- 5 the needs workgroup. And as the co-chairs had
- 6 information that they would like to post, we could post
- 7 it up here. We could do the same for FCAS and the
- 8 special projects group, et cetera, et cetera.
- 9 So I think we have a lot of flexibility. It's
- 10 sort of just figuring out a game plan and the best way
- 11 to get documents up there. I cannot promise real time,
- 12 but we will do our best, and we'll look into that.
- I know that document, version control was a very
- 14 big concern in the past. So we heard -- we heard the
- 15 concerns, and we're doing our best, and we will make
- 16 sure to try to get everything as speedily to you as we
- 17 can. We just want to make sure that we are getting the
- 18 version control down to you.
- 19 Another thing is our contact information. So you
- 20 can feel free to call me at any time. I'm the project
- 21 director. So you can give me a call. That's our main
- 22 number, and then the email address is somewhere here.

Jenver, CO

- 1 I don't know where it is. You can fill out the form,
- 2 or you can also contact me, and I'll post the email
- 3 address up on the other screen.
- 4 MS. VELEZ: If you click on email, it will pull it
- 5 up if you have that there. Well, you don't have -- no,
- 6 you don't have a --
- 7 MS. FIALA: So I'll post it up on the other
- 8 screen, and I will make sure that it's up there on the
- 9 mainline as well. But it's
- 10 ihbgrulemaking@firstpic.org. And again, I'll post it
- 11 up on the other screen so you have that as well.
- But we'll make some changes. We'll make alerts.
- 13 I think there was a request to have an email alert sent
- 14 out once we posted new documents in the Member section.
- 15 So that's all something that we can work on, and we'll
- 16 do our best to address all the concerns that you had
- 17 and make sure we get it up as soon as possible.
- 18 Thanks.
- 19 MR. DOLLARHIDE: All right. Thank you, Sara.
- 20 Anybody have any questions for her?
- 21 (No response.)
- MR. DOLLARHIDE: Seeing none, we'll just go ahead

- 1 and move on. We're really -- we're cutting close time
- 2 here. We still have public comments that we need to
- 3 get through also, if there is any. So we'll go ahead
- 4 and start with the committee reports or the workgroup
- 5 reports, should I say.
- 6 Whichever one -- Carol, Sami Jo, or Jason -- who
- 7 wants to go first?
- 8 MS. DIFUNTORUM. Hi. I'm Sami Jo Difuntorum. It
- 9 looks like I'm volunteering to go first. Thank you.
- 10 Okay. So this morning we met, and the needs
- 11 workgroup, the first thing that we did was appointed a
- 12 co-chair. It's a pretty large group. There is a lot
- of -- lot of information to handle and an awful lot of
- 14 people. So Carol Gore has very graciously agreed to
- 15 co-chair that workgroup with me, and I appreciate that
- 16 a great deal.
- 17 The next order of business, we divided the group
- 18 into two groups, and we took the list of items from the
- 19 matrix yesterday, and as a group, we tried to develop
- 20 subgroups, basically taking the items that were similar
- 21 and seeing what made sense as far as developing sub-
- 22 workgroups to the major workgroup. Sounds kind of

- 1 confusing.
- 2 But anyway, we got back together, and we agreed on
- 3 two sub-workgroups. One will be weighting factors,
- 4 data source -- well, data source factors and weights.
- 5 Ah, it's on the screen. And then formula geography and
- 6 mechanics. Since you can see it, I'm not going to go
- 7 through each item in each group.
- 8 And that took up the majority, in fact, all of our
- 9 morning. When we reconvened in the afternoon, we had
- 10 two priorities. One was basically establishing an
- order of business and how -- how we're going to
- 12 function as a group. So during lunch, Carol, Blake,
- 13 and I spoke -- well, we had -- I took Earl Evans at his
- 14 suggestion. We came up with some guidelines for the
- 15 needs workgroup.
- 16 And so, the workgroup as a whole sat down and
- 17 looked at them, and this is what we've decided to use.
- 18 And it talks about how we advance proposals from the
- 19 group, minority opinions, majority opinions, and how
- 20 all of that works in relation to the workgroup and the
- 21 sub-workgroups and how proposals move forward.
- 22 The other item we talked about -- this is an

- 1 important one. This is our tech request. That was the
- 2 other item we had passed. So we had our tech request
- for HUD, and some of it's already been covered, but I'm
- 4 going to go ahead and repeat because it was put forward
- 5 from the workgroup.
- 6 So at the next meeting, record-keepers for the
- 7 subgroups, the two subgroups, in addition to the
- 8 committee. Lots of microphones. Part of what kind of
- 9 slowed us down was passing the two around to a pretty
- 10 large group. I think we probably have, what, 50 people
- in our group, in our workgroup. It was pretty large.
- 12 So we would like that.
- 13 Two meeting rooms. A table that's circular and
- 14 better configured. We had so many people that we had
- 15 some folks at the table, and then another row of chairs
- 16 behind us. And we would really like for everybody to
- 17 be at the table so that everyone feels they're equally
- 18 engaged and have that opportunity to be part of the
- 19 conversation.
- 20 Have better connectivity in the meeting room
- 21 because we had some issues with people's Internet
- 22 dropping.

- 1 2009 statutory amendments. Any guidances and PIH
- 2 notices that affect the formula. And we would also
- 3 like those posted at the Web site.
- 4 Contact information for all attendees. There was
- 5 a request for FirstPic to set up a library system that
- 6 shows all the data runs that are requested so that we
- 7 have access to those and we all know. And I think that
- 8 would take away from the issue of duplication if we're
- 9 able to see those on the Web site.
- 10 And the last was a number and tracking system for
- 11 proposals that come out of the workgroup and documents
- 12 in general.
- And so, the last thing that we talked about was
- 14 next steps and where we're going when we meet again,
- and probably there will be some discussion and rehab of
- 16 where we left off. But our primary goal when we get
- 17 back together is divide into the two sub-workgroups and
- 18 start with the task of prioritizing the list, hopefully
- 19 going for what's called the low-hanging fruit, the
- 20 things that are going to be the easiest to get complete
- 21 agreement on so that we can advance those forward to
- 22 the full committee. And the intent is to advance

- 1 proposals forward as we have agreement in our
- 2 workgroup.
- 3 So it was an interesting experience, and I thank
- 4 everybody that participated today.
- 5 MR. DOLLARHIDE: Thank you, Sami Jo. Jason?
- 6 MR. ADAMS: Didn't want to forget Coco.
- Jason Adams, Salish Kootenai. As far as the FCAS
- 8 workgroup, we began this morning where we had agreed to
- 9 yesterday was a discussion on additional items for the
- 10 matrix, and so we picked that issue up and began there.
- 11 And we had a listing from NAIHC, and there actually
- 12 ended up being two listings from NAIHC, a listing whose
- issues that came from -- what is it, 2008, 2009. And
- 14 then there was issues that were directly from the
- 15 amendments that were being proposed to the statute in
- 16 2010.
- 17 And so, we addressed those issues. Most of them
- 18 were either covered or they were given to the other
- 19 workgroup. And some of them were given to the needs
- 20 workgroup. So we want to make sure we communicate
- 21 that. We have our list up there. I think we're going
- 22 to communicate this list to you. But the items that

- 1 came from that discussion will be on the list.
- 2 Then we -- we took a break after that and talked
- 3 about our decisionmaking process. I think this was
- 4 actually a very good discussion. But at some point, we
- 5 broke and had a quick discussion to make sure that we
- 6 formalized within our own group our own understanding
- 7 of how we were going to make decisions.
- 8 We agreed yesterday that we would follow Robert's
- 9 Rules of Order. And so, we agreed today, just further
- 10 agreed that there would be a motion and second on all
- of the items that we're going to be making a decision
- 12 on. And we did have a few of those today.
- And then we agreed that in the future, if there
- 14 was a strong minority opinion, that that would be
- 15 pushed forward as well as the majority opinion, and
- 16 those items would be brought to the committee.
- 17 Then we went back and we went through the matrix
- 18 list with our inclusions, our additions, and we started
- 19 to list those items, just essentially talk about them
- 20 again and see if there was items there that we needed
- 21 to have a further discussion on in the future as far as
- 22 proposals and how they moved forward.

- 1 Some of these items -- we had, I think, 18 items
- 2 that were given to us after the brainstorming
- 3 yesterday. Some of them are going to be combined.
- 4 Some of them were tabled kind of issues that really
- 5 didn't require us to do much that will be covered in
- 6 other work. And so, our list whittled down to eight
- 7 items.
- And so, that's really where we're at now is we've
- 9 got eight items off of this list or eight areas, I
- 10 guess I should say. Maybe that would be a better way
- 11 to term it. Because some of these areas are going to
- 12 be pretty large, but we're going to have the discussion
- in the one area. And so, we have really those eight
- 14 areas that we're going to take a look at and get to
- 15 work on.
- We did finish up by talking a little bit about
- 17 communication between now and when we meet again. One
- 18 of the issues there was an email list, and we did hand
- 19 out a sign-up sheet for everybody that wanted to be
- 20 included on an email process for the FCAS workgroup.
- 21 And I would make that available to anybody else
- 22 that's in the needs workgroup that they want to come

- 1 up, I think I gave that to Sara, and she has that. So
- 2 if you're interested in being a part of the
- 3 distribution of emails that's going to be a part of our
- 4 workgroup, you can add your name to that list, and she
- 5 can -- she can follow up with you on that, and you'll
- 6 get all the information.
- 7 One of the big projects, and I saw it was on your
- 8 list, too, that we were talking about that's going to
- 9 take some time is going through all the PIH notices and
- 10 guidances and even some of the HUD practices that we
- 11 wanted to take a look at and see how they affect FCAS.
- 12 And so, that's going to be one of the big projects we
- work on between now and the next meeting.
- I think that was it. I think I've covered mostly
- 15 everything that we talked about. Again, I'm not going
- 16 to read this to you. There's a lot of information
- 17 there as far as what we discussed, the items that are
- 18 going to be included, how we put things together.
- 19 So is there any questions, comments on this?
- 20 Committee members or workgroup members, did I forget
- 21 something? If not, that's my report, Mr. Chairman.
- 22 MR. DOLLARHIDE: Thank you. Is there any

- 1 questions of the workgroups?
- 2 (No response.)
- 3 MR. DOLLARHIDE: Seeing none, we've got about --
- 4 about 7 minutes before -- before we need to move on to
- 5 public comments. I think this, if Sandra is ready, to
- 6 kind of give us just a brief update? I think we are
- 7 fine to put this under the agenda for the next staff's
- 8 -- oh, we got one question. Mr. Adams?
- 9 MR. ADAMS: I apologize. I was just -- if we have
- 10 some time here on the agenda, I would like to add an
- 11 issue that came up in our caucus. Do you want me to do
- 12 that now?
- 13 MR. DOLLARHIDE: Yes.
- 14 MR. ADAMS: In our regional caucus, we talked
- 15 about kind of what happened yesterday, you know, as the
- 16 day wore on and folks were kind of slumping in their
- 17 chairs --
- 18 MR. DOLLARHIDE: Jason?
- 19 MR. ADAMS: Yes? Sorry.
- 20 MR. DOLLARHIDE: I have discussed that with some
- 21 of the HUD officials, and they need to -- they need to
- 22 consult with their legal on the beverages, et cetera.

- 1 So that we could discuss that, but that has been
- 2 brought up. And they were pretty adamant that it
- 3 needed to be brought up with legal. It's going to be
- 4 some emails that will have to be processed, I guess, to
- 5 their legal team and stuff like that.
- 6 So that is something that we can get back with you
- 7 on. I apologize. I didn't mean to cut you off. So,
- 8 but --
- 9 MR. ADAMS: Just to finish, you know I did offer
- 10 to sponsor afternoon break at one of the next meetings,
- 11 if that would help? You know, a cookie or some chips
- 12 or soda or something in the afternoon. Something to
- 13 keep you from slumping in your chair like we saw
- 14 yesterday, that would be good.
- So that was the issue I wanted to raise. Thank
- 16 you.
- 17 MR. DOLLARHIDE: Thank you, Jason. Sandra?
- 18 MS. HENRIQUEZ: Thank you. Let me just start by
- 19 responding to what Jason said. If any of you might
- 20 remember, a while ago there was a series of articles, I
- 21 hesitate to use the word "scandal," but a series of
- 22 articles regarding the General Services Administration,

- 1 GSA, and an offsite retreat that they had.
- 2 They had videos of people doing the electric
- 3 slide. There were a number of things, followed by a
- 4 request from Congress to every Federal agency to send
- 5 to Mr. Issa of California for 5 years' worth of every
- 6 conference, either sponsored by a Federal agency or in
- 7 which more than X number of Federal employees from a
- 8 particular agency attended, both cost, location,
- 9 agenda, reason for someone's attendance. The list went
- 10 on.
- And so, it has become then the practice for all of
- 12 us to scrub, if you will, our contracts for events.
- 13 And so, that's why you don't see -- why you do see just
- 14 the minimum, and getting coffee in the morning was even
- 15 a big to-do.
- So that's why we have to go back and talk to our
- 17 legal folks, what that means, what can we do, et
- 18 cetera, et cetera. You can't make this stuff up.
- 19 (Laughter.)
- 20 MS. HENRIQUEZ: So I just thought I'd -- I should
- 21 offer you the reason why because it seems like such a
- 22 simple thing, and that's the reason we're all sort of

- 1 in this chugging along.
- Okay. So on to the other topic, which is what do
- 3 we forecast as what's going to happen. I've been
- 4 watching -- while you all have been in workgroups, I've
- 5 been watching CNN and Fox News and MSNBC and making
- 6 phone calls and emails, and Heidi Frechette has been
- 7 doing the same thing as well to try and see who's got
- 8 the best read of the tea leaves.
- 9 We have 12 days and counting until the end of the
- 10 Federal fiscal year. So if something doesn't happen by
- 11 midnight of September 30th, we don't have a budget and
- 12 we then have to wait.
- 13 As you know, it's not just a simple budget issue.
- 14 There is the whole issue of is it a we think will be a
- 15 75-day continuing resolution, which would then take us
- 16 into mid December.
- Somewhere along that line, there may or may not be
- 18 a discussion about the debt ceiling as well. They
- 19 think that that conversation may have to take place
- 20 somewhere in mid to late October, given the payment
- 21 schedule for interest payments by the Federal
- 22 Government.

1 That's to say that's as much as we sort of know

- 2 now. If the 75-day continuing resolution is passed
- 3 before -- and signed by the President before midnight
- 4 on September 30, it means that we can move forward with
- 5 the same amount of money that we had in our 2013 budget
- for October, November, and the 15 days of December
- 7 unless -- at exactly the same spend rate.
- 8 So we would not be able to start having another
- 9 negotiated rulemaking session because it would cause us
- 10 to spend more money in October or November under the
- 11 Federal fiscal -- the new budget than we spent a year
- 12 before in the F-12 months, the same month 12 months
- 13 ago, unless there's something called an anomaly that's
- 14 placed in the budget. An anomaly is either language or
- 15 a dollar amount which then that becomes the new
- 16 benchmark, if you will, for that period of the
- 17 continuing resolution.
- 18 Heretofore, anomalies have not been allowed by the
- 19 Office of Management and Budget on a short-term
- 20 continuing resolution. It's only when we get into a
- 21 yearlong continuing resolution that anomaly language
- 22 and/or dollar amounts have been asked for from the

- 1 Federal agencies. They may not always go forward, but
- 2 at least we can put them in and see if they live or
- 3 die.
- 4 So the first 75 days, if we have a CR, it will be
- 5 straight on what was in 2013. Oh, but it also may
- 6 include another whack at the 8 percent sequester amount
- 7 that would be available for the entire year, but
- 8 prorated for the life of that short-term sequester.
- 9 All that to say that's why we did talk about to
- 10 keep the momentum going, if there were other
- 11 alternatives for workgroups to meet, to talk, to try
- 12 and get some things moving, as opposed to coming to
- 13 sort of a dead halt now, and then not knowing yet when
- 14 we all might be around this table again, when and
- 15 where.
- We were trying to figure out if there's some
- 17 method as to keep the work going, keep your juices
- 18 flowing, have you consider the things that you
- 19 rightfully want to talk about, which you could do in
- 20 the workgroups and then come back to the larger
- 21 committee. Just at least suggestions so that we don't
- lose the proverbial fire in our bellies to get this

- 1 work done.
- 2 So that's the long-winded way of saying I don't
- 3 know. As we learn more, we can certainly send
- 4 something out to try and tell you more. But you're
- 5 reading the press the same way we are. You're looking
- 6 at the same news reports the same way we are. There is
- 7 nothing that we're learning that's sort of a close-hold
- 8 secret that the public doesn't already know.
- 9 So we may not have new information. In fact, at
- 10 times, you may information that's identical to ours,
- 11 and you might get it faster than we get it being inside
- 12 the beltway.
- So sorry it's not good news. Hopefully, it will
- 14 become better news. But I wouldn't count on it anytime
- 15 soon.
- 16 Thank you.
- 17 MR. DOLLARHIDE: Mr. Evans?
- 18 MR. EVANS: Earl Evans, Haliwa-Saponi Indian
- 19 Tribe. Thank you, Mr. Chairman, for recognizing me.
- I wanted to, if I may, just a couple of things
- 21 that I think we forgot earlier. Excuse me. Well, I'm
- 22 sorry. Just one thing that I may have forgot earlier,

- 1 which is there was a suggestion sometime during one of
- 2 the needs workgroup meetings we had where it was
- 3 suggested that perhaps the workgroup chairs should meet
- 4 along with the committee chairs at the end of the day
- 5 after the -- before the committee adjourns from the
- 6 meeting in order to kind of sum up everything that's
- 7 occurred and plan for the next meeting.
- 8 So I wanted to make that for the record because I
- 9 think we've forgotten that recommendation, and that's
- 10 probably important in terms of planning processes.
- 11 And the other thing, since we were talking about
- 12 the budget, the next meeting, whenever that does come,
- 13 if -- since I didn't get anybody interested in Hawaii,
- 14 I might make a different suggestion to see if I can get
- 15 some support for Raleigh, North Carolina, that that's
- 16 being considered. Because the last time negotiated
- 17 rulemaking, I don't think we went anywhere in the
- 18 Eastern region, in the Chicago region.
- 19 So I would like to make that request for the next
- 20 meeting. And if not the next meeting, at least
- 21 sometime during the next six meetings, we would like to
- 22 see an Eastern region meeting, and I'm suggesting

- 1 Raleigh, North Carolina, if I may?
- 2 Thank you.
- 3 MR. DOLLARHIDE: Thank you, Mr. Evans. That's
- 4 noted.
- 5 Any other comments before we take public comments?
- 6 (No response.)
- 7 MR. NICHOLS: Okay, thank you, Mr. Chairman.
- 8 And this is the portion of our agenda where we
- 9 open the floor to the members of the public to address
- 10 the committee. We have two microphones available for
- 11 you, and I would like to invite those of you in the
- 12 audience to express any comments or questions you have
- 13 for the committee. Last call for public comments.
- 14 (No response.)
- 15 MR. NICHOLS: Okay. Looks like, Mr. Chairman, we
- 16 have no comments from the public today. So I'll hand
- 17 the baton back to you.
- 18 MR. DOLLARHIDE: Yes, Ms. Foster?
- 19 MS. FOSTER: Karin Foster. I just have a
- 20 question. I know I'm out of order, and I apologize,
- 21 but did we not have a third workgroup that was other?
- Were we going to hear from them about what they did?

- If there isn't a report, I guess that's fine.
- 2 Maybe there wasn't a whole lot that they could do.
- 3 They didn't have a lot of issues, but I guess I just
- 4 want to make sure that they're still on the board if
- 5 they do exist as a committee and we do hear from them
- 6 maybe next time.
- 7 MALE SPEAKER: He didn't come out of his room.
- 8 (Laughter.)
- 9 MR. DOLLARHIDE: Heather?
- 10 MS. CLOUD: They're sitting in the parking lot,
- 11 and our guidelines were try to elevate them.
- 12 (Laughter.)
- MR. DOLLARHIDE: My apologies on that third group.
- 14 Do we have anybody? I know Ron Kowal said that he was
- 15 going to make it in there. Okay, we've got --
- 16 MR. KLINGBEIL: Kevin Klingbeil, Big Water
- 17 Consulting. Yeah, there were three of us in there. So
- 18 as I mentioned to Jim, we spent most of our time
- 19 putting a paltry email list.
- 20 (Laughter.)
- 21 MR. KLINGBEIL: But -- and T-shirts, of course.
- 22 But the primary thing that we realized is, given that

- 1 most of the issues that end up in other are issues put
- 2 forward by one person or somebody who has a particular
- 3 interest in an issue, if they're not in that committee
- 4 or in that working group, then we really don't have
- 5 much we can do with that issue.
- In other words, we don't fully understand, one,
- 7 why they raised the issue unless there's some sort of
- 8 various statement that supports it. And then if the
- 9 three people that are in there don't necessarily agree
- 10 or support that issue, then there's no one to carry it
- 11 forward.
- So one of the things that we would recommend is if
- 13 things do get pushed to the other committee, that
- 14 whoever that person is who put that issue forward needs
- 15 to come and sort of be part of that and carry that
- 16 forward separately within that working group as well.
- 17 Because, you know, we were working hard getting that
- 18 email list together and trying -- initially we were
- 19 trying to decipher all these different issues and make
- 20 heads or tails.
- 21 But you're trying to stay true to whatever it is
- 22 that the person was thinking when they proposed it, and

- 1 you don't always know what that is. I mean, we'll have
- 2 some nice T-shirts, but I think really at the end of
- 3 the day, if things are going to get pushed to the
- 4 other, you need to decide whether the issue is, in
- 5 fact, going to stay alive within the committee because
- 6 I think some of those issues are issues that sort of
- 7 got swept out of the two primary committees to that
- 8 one. And if not, then are we just going to let it go?
- 9 So that's -- that's our report, and I think
- 10 unless, Ron, you've got more to add, I think we'll
- 11 valiantly carry on our duties there. What is it,
- 12 supporting other projects, special projects, or as
- 13 Lafe, I think, put it, special needs workgroup.
- 14 Thank you.
- MR. DOLLARHIDE: Mr. Adams?
- 16 MR. ADAMS: I hope I'm not -- Jason Adams, Salish
- 17 Kootenai. I hope I'm not speaking out of order in
- 18 regards our workgroup. But if we don't get any
- 19 response at our next meeting for that workgroup, I
- 20 would hope that maybe we could be looked at as
- 21 reassuming those duties and adding them to our list
- 22 because our areas of concern are pretty small right

- 1 now. So we could probably take that on if we had to.
- I'm offering for that to come to us if need be.
- 3 MR. DOLLARHIDE: Appreciate that. Mr. Evans?
- 4 MR. EVANS: Thank you, Mr. Chairman. Earl Evans,
- 5 Haliwa-Saponi Indian Tribe.
- I want to know if the special projects workgroup
- 7 broke out into very many sub-workgroups or not. But --
- 8 (Laughter.)
- 9 MR. EVANS: -- one of the things that I will say,
- 10 though, is I still commend them for meeting and
- 11 reporting back on the issues, and I think that the
- 12 folks that we've appointed to chair these working
- 13 groups and the folks that we've got chairing the
- 14 committee so far have been doing an outstanding job.
- 15 And I appreciate your time, your efforts, your
- 16 commitment, and your service.
- 17 Thank you, Mr. Chairman.
- MR. DOLLARHIDE: I concur with that.
- We are on the closing remarks. For myself, I
- 20 would like to say a few things, and then, you know, I
- 21 will send it around the table to kind of open it up,
- 22 you know, for closing remarks before we do close with a

- 1 prayer.
- I want to say that, you know, it has been an
- 3 experience sitting right here where I'm at. It's been
- 4 interesting at times. It's been nervous at times.
- 5 It's been frustrating at times. I do appreciate all
- 6 the suggestions, all the advice that has been given to
- 7 me by my fellow committee members.
- I do take them seriously. I take this position
- 9 very serious, I guess. You know, I guess as serious as
- 10 what I can take it. And I appreciate everybody's
- 11 patience with me as I grow in this position. And I'm
- 12 sure that Annette would also convey those remarks.
- I appreciate the participation by the audience,
- 14 all the support staff. I appreciate without those
- 15 folks sometimes our jobs would be much harder than what
- 16 they are. So I do appreciate that from my standpoint.
- I appreciate the HUD folks that have graciously
- 18 taken their time to help us as a committee, and I want
- 19 to personally wish everybody safe travels. If I don't
- 20 see you before the holidays, I wish you happy holidays
- 21 and Merry Christmas.
- 22 (Laughter.)

- 1 MR. DOLLARHIDE: Happy New Year. So thank you.
- 2 So I will open it up for the committee, if there
- 3 is any remarks before we do close this with a prayer.
- 4 Thanks.
- 5 MS. HENRIQUEZ: I just wanted to say, Jason,
- 6 subject to funding availability.
- 7 MR. DOLLARHIDE: Mr. Cooper?
- 8 MR. COOPER: And Jason, I appreciate, and this is
- 9 my first time here. This is my second meeting. It's
- 10 been an experience, to say the least. But I do
- 11 appreciate yours and Annette's leadership, and not just
- 12 your all's, but also the committee -- the workgroups.
- I mean, I think I don't know about you all, but I
- 14 think that we've got a lot accomplished in the short
- 15 time that we've been together and the short time that
- 16 we have met. And whenever, you know, subject to
- 17 funding availability and we can meet again at some
- 18 point in the future, I think that at least we have -- I
- 19 think we did get a lot done, and I don't think that we
- 20 could have done that or that we could have gotten there
- 21 without your all's help.
- 22 And I do want to say thank you all for that, and I

- 1 think that you all deserve a hand for all your hard
- 2 work. And I appreciate all that you've done.
- 3 (Applause.)
- 4 MR. DOLLARHIDE: Is there any more comments from
- 5 the committee? Heather?
- 6 MS. CLOUD: I just want to add on to what you
- 7 said, and I just want to say Happy Easter, subject to
- 8 funding availability.
- 9 (Laughter.)
- 10 MS. CLOUD: And if we get to meet before Easter, I
- 11 would hope that we don't have any of those meetings in
- 12 the Midwest. Thank you, and I had an enjoyable time
- 13 working with all of you.
- 14 MR. DOLLARHIDE: Okay. Seeing no more, Sandra?
- 15 MS. HENRIQUEZ: I always enter negotiated
- 16 rulemaking with some trepidation, and I always come
- 17 away with feeling that that was silly for me to have
- 18 those feelings up front. I do want to say thank you to
- 19 every single committee member here and to your staffs
- 20 and colleagues who came in support.
- I want to say thank you to the members of the
- 22 public who have dwindled some but have stuck it out

- 1 with us in this session, and I most especially want to
- 2 thank the HUD staff that is here. These are the folks
- 3 that you all work with day in and day out, and I think
- 4 that they are a singularly spectacular group of
- 5 individuals who take all of what you do to heart and
- 6 very personally, really count on your success as being
- 7 their own.
- 8 So on behalf of the Secretary and myself, thank
- 9 you. While we can joke about subject to funding
- 10 availability, we will do all we can to see how quickly
- 11 we can all get back together around this table face-to-
- 12 face and engage in the work that we're doing.
- I do want to say that we will fulfill all of the
- 14 data requests that we get. There's no blue smoke and
- 15 mirrors. There's no guile. Our role simply is to
- 16 provide you with the data that you ask for.
- If you believe that somehow we've made a mistake,
- 18 you should please call that to our attention. If there
- 19 are other sources and reports of information that you
- 20 want, we will do everything we can to make that
- 21 available to all of you, as well as post it.
- Our goal is to be as transparent as possible so

- 1 that this process, as difficult as it may be, because
- 2 it's a difficult topic to tackle that when it involves
- 3 money, we will do all we can to help facilitate that.
- 4 That is our role. That's our agenda. That is our only
- 5 agenda, contrary to what you may hear buzzing around
- 6 from time to time.
- 7 And with that, I, too, wish you all safe travels.
- 8 It's been a pleasure. I've learned more, again, this
- 9 time. Thank you for that.
- 10 And let's just move forward and get this process
- 11 rolling, keep it on track, and have the best outcomes
- 12 for all of the people all of us are here to represent
- 13 and serve.
- 14 Thank you.
- 15 MR. DOLLARHIDE: Thank you. Any more comments?
- 16 (No response.)
- MR. DOLLARHIDE: Seeing none, I would ask Blake to
- 18 close us out.
- DR. KAZAMA: Before I close in prayer, I just
- 20 wanted to explain why I'm at this table. It's the
- 21 chairs are more comfortable.
- 22 Actually, I'm an alternate for Teri Nutter, Copper

- 1 River Basin, and I think that's critical to announce
- 2 and state because in past negotiated rulemakings, we've
- 3 had alternates come and go at this table, and it
- 4 created some confusion. So I just want to share that
- 5 with you that I'm an alternate for Teri Nutter.
- 6 So could we stand, and I'll close in prayer.
- 7 Father, in the past few days, we've worked really
- 8 hard. Thank you that we were able to accomplish so
- 9 much. Thank you for your guiding hand.
- 10 But one thing we realize, Father, in the coming
- 11 months to come, as we deliberate over this very
- 12 critical issue, that there's yet a lot of work to be
- 13 done. Father, give us the wisdom that you gave
- 14 Solomon. Give us the patience that you gave Job. And
- 15 Father, give us the love and forgiveness that you
- 16 bestowed on Joseph towards his brothers.
- 17 Father, a lot of emotions go through each one of
- 18 us as we deliberate, and sometimes we're frustrated
- 19 with trying to negotiate our very critical issues. So
- 20 give us the patience and the love for one another that
- 21 at the end of the day, we know that the reason we
- 22 argue, we negotiate hard is because we represent people

Page 78 1 who could not be here to negotiate for themselves. Many are suffering. Many are hurting. 2 Many are without homes. Many have been waiting for a long time. 3 So, Father, please give us the heart. We know there 4 is only so much money. Give us the wisdom in how to 5 6 deliberate and do the right thing for our people. 7 And Father, I ask that each one of us have a safe trip home to be reunited with family, to again take on 8 or continue where we left off, to continue to do the 9 10 work, good work and, Father, to look to you for guidance in all that we do. 11 12 Thank you so much that we could visit with old 13 friends and meet new people.
