- 2 MR. VIGIL: Father, as we come into Your presence,
- 3 we seek your blessing, Lord, on this meeting. Father,

- MS. BRYAN: Thank you, Rodney. Next on the agenda
- 3 we have a welcome from Jemine Bryon.
- 4 MS. BRYON: Good morning, everyone. I hope
- 5 everyone had safe travels, and I bring you greetings
- 6 from our Secretary, Julian Castro, who has made a
- 7 commitment to visit as many of the tribes as he can.
- 8 He is very interested in the work that we are doing
- 9 here, and I am trying to keep him as well informed as
- 10 possible. But very, very supportive of all that we are
- 11 trying to achieve in these sessions.
- 12 This is our last of six sessions for this -- for
- 13 this year. I'm really excited by the progress that was
- 14 made. Certainly session number five was very, very
- 15 productive, and I thank you and, again, commend
- 16 everyone -- the full committee, working group --
- 17 everyone who contributed to the effort to date.
- I look forward to this last session being just as
- 19 productive and coming to resolution on some issues. We
- 20 are excited. The HUD team is here engaged and ready to
- 21 -- ready to lend whatever support and participation as
- 22 is necessary. We will be back in one year for one last

- 1 time to go over the recommendations of the study group,
- 2 mainly for that reason, and hopefully to come to
- 3 consensus on what the next data source will be that we
- 4 will use for the needs formula.
- 5 So again, it's an exciting -- I hope it's a
- 6 productive year. And, again, HUD will participate and
- 7 lend any assistance that is necessary to the study
- 8 group. We are excited and look forward to in less one
- 9 year hearing what those recommendations are.
- I think it's important to give the work groups
- 11 today as much time as possible to bring all issues so
- 12 that the full committee can complete its work most of
- 13 tomorrow and Thursday. But again, if we make as much
- 14 progress as we did the last time, I am very hopeful
- 15 that we'll conclude this session on a positive note.
- 16 So thank you all very much. We are ready to go.
- 17 MS. BRYAN: Thank you. Next, Jason Dollarhide and
- 18 myself would like to welcome each and every one of you
- 19 back to the table for negotiated rulemaking as well as
- 20 HUD staff, and our Tribal Housing Authority support
- 21 teams, and our public who came to join us today. And I
- 22 hope for productive working group session as well as

- 1 productive negotiations further on this week. So we've
- 2 designed the agenda so that we can hope those things
- 3 will happen.
- 4 Next we have hotel logistics and housekeeping
- 5 items from FirstPic.
- 6 MS. VELEZ: Good morning, everyone. Welcome to
- 7 Scottsdale. It's nice to see everyone once again.
- 8 Sarah is not able to join us today, but she will be
- 9 here tomorrow. But please rest assured that the full
- 10 FirstPic team is here to help you with whatever you
- 11 need.
- To just go over the map of where our breakout
- 13 rooms are -- here we go. So as you see, we're in the
- 14 Grand Ballroom, which is the giant orange room. And
- 15 all of our breakout rooms this time are down the same
- 16 hallway, which makes it very easy. If you go out the
- 17 back doors and turn to the right and then to the right
- 18 again, all the breakout rooms are on this hallway to
- 19 our right. There's restrooms downstairs down there as
- 20 well. And as you go down the stairs, there's one
- 21 breakout room one floor beneath us.
- Just a sec. You can see the room assignments

- 1 there for the caucus rooms and also for FCAS, the Full
- 2 Needs Work Group will be downstairs in the Southwest
- 3 Room. And the smaller breakout rooms are for the sub-
- 4 groups for the needs sessions.
- 5 And finally, if you need to use Wi-Fi, the user

- 7 For better connection in each of the breakout rooms,
- 8 you can find the wireless connection for that room, and
- 9 then once the login screen appears, you can enter the

- MS. BRYAN: Thank you. At this time we'd like to
- 13 do a quick roll call to establish our quorum. We can
- 14 start with Leon.

- 6 MR. OKAKOK: Samuel Okakok, Native Village of

- 8 MS. VOGEL: Good morning. Sharon Vogel, Cheyenne
- 9 River Housing Authority.
- 10 MS. BRYON: Good morning. Jemine Bryon,
- 11 Department of Housing and Urban Development.
- MR. BOYD: Good morning. Rodger Boyd with ONAP.
- 13 MR. COOPER: Good morning. Gary Cooper, Cherokee
- 14 Nation.
- MS. FOSTER: Good morning. Karin Foster, Yakama
- 16 Nation Housing Authority.
- 17 MR. HAUGEN: Good morning. Lafe Haugen, Northern
- 18 Cheyenne Housing Authority in Montana.
- MS. BRYAN: Thank you. And we do have word that
- 20 Heather Cloud will be joining us as soon as her flight
- 21 arrives. So we do have a quorum, so let's get to work.
- Right now we're going to do committee review and

- 1 approval of the proposed agenda. So as I had discussed
- 2 earlier, we have set the first two days for work
- 3 groups, so we'll open up in this format in the morning
- 4 and check in with our work groups, and then break into
- 5 work groups, coming back here at 5:00 p.m. to close the
- 6 meeting with public comment and prayer. And you do see
- 7 on the agenda we are working into the evenings if
- 8 needed. We will have our -- they're set up until 8:15
- 9 in the evening. So that's one day one.
- 10 Day two is the same setup, and then on day three e
- 11 will, of course, be flexible, but we've set it up so
- 12 that we have full committee work groups as determined
- 13 by day two into the afternoon and then, you know, or
- 14 actually opening if we're ready on day three to go into
- 15 full committee.
- So that's how it's established now, and we'll move
- 17 for approval or any suggestions for changes.
- 18 (No response.)
- MS. BRYAN: Do we have consensus on the agenda?
- 20 Please indicate with a thumbs up or down.
- 21 (Show of approval.)
- MS. BRYAN: Okay. I believe I'm seeing approval

- 1 for the agenda. We have reached consensus early on.
- 2 Thank you. Now, next on our agenda is approval and
- 3 review of the minutes from our July session from the
- 4 29th to the 31st of 2014.
- 5 MS. DIFUNTORUM: Okay. So I was looking at the
- 6 transcripts, and I have some changes to that. I know
- 7 we're not approving the transcript, but how would --
- 8 who would I talk to to make corrections to that?
- 9 MS. BRYAN: I'm going to ask FirstPic. Who would
- 10 we talk to about making changes or corrections to the
- 11 transcript?
- MS. VELEZ: You can talk to me.
- 13 MS. BRYAN: Talk to Christie. Okay, thank you.
- 14 We'll just take a minute to look at what's in front of
- 15 you, and then hopefully we've read these.
- 16 (Pause.)
- MS. BRYAN: Are we ready to vote on the minutes?
- 18 (No response.)
- 19 MS. BRYAN: All right. Do we have consensus for
- 20 the approval of the minutes for July 29th through the
- 21 31st of 2014? Please indicate with a thumbs up.
- (Show of approval.)

- 1 MS. BRYAN: Okay. We have an abstention. How
- 2 does that work for consensus? Thank you. The minutes
- 3 are approved.
- 4 Next on the agenda we have FCAS and Needs Work
- 5 Group Review with Jason Adams and Gary Cooper. So
- 6 we'll start with the FCAS, please.
- 7 MR. ADAMS: Thank you, Co-Chairs. Jason Adams,
- 8 Salish-Kootenai Housing Authority. This is, in a way,
- 9 a review for the FCAS Work Group. The information -- I
- 10 feel like this has just become repetitive to the work
- 11 group or to the committee, so I'll be as brief as I can
- 12 be.
- 13 We have a document that has our 10 items that
- 14 we've been working on. It's available on the website.
- 15 And we have five of those items that we are working on
- 16 language on that we will be bringing back to the table
- 17 here as soon as we can get through those items in the
- 18 next couple of days. So that's really where we're at.
- 19 If you're interested or want more detail, please come
- 20 join in the FCAS Work Group. But we will be getting
- 21 here shortly this morning.
- 22 And I do want to say on another note that I'm

- 1 privileged this morning to sit next to the guest of the
- 2 day, Jack Sawyers. And he -- they should've made him
- 3 guest of the day on Thursday because Thursday is Jack's
- 4 birthday. So just to let you all know that. Thank
- 5 you.
- 6 MS. BRYAN: Thank you, and welcome, distinguished
- 7 guest.
- 8 (Laughter.)
- 9 MS. BRYAN: Next, we have Gary Cooper for the
- 10 Needs Work Group.
- MR. COOPER: Okay. And this morning before we go
- into a full work group, we'll allow our three
- 13 subgroups, which is Overlapping Formula Areas, Minimum
- 14 Funding, and Data Challenges, to meet for about 30
- 15 minutes to give them time to come back and regroup from
- 16 our last session. And I think all of them have items
- 17 that either they are finished up on or just need to put
- 18 the finishing touches on to bring to the full work
- 19 group. And then we can see where we're at from there,
- 20 and then see if we can't find some more issues to
- 21 tackle.
- But whenever we break into full work groups, those

- three subgroups, 30 minutes, and then we'll come back
- 2 as a full work group to see where we're at. And I
- 3 believe that they have assigned breakout rooms for each
- 4 of the subgroups. So just to kind of give you all an
- 5 update there.
- 6 We would invite anyone who wants to participate in
- 7 any of those groups to either join them in the sub-work
- 8 groups or come back to our full work group. Again,
- 9 those three sub-work groups are Overlapping Formula
- 10 Areas, Minimum Funding, and Data Challenges. And you
- 11 can see that each of those are assigned a room, so
- 12 we'll give them about 30 minutes to re-collect from
- 13 their last session, and then come back to the full work
- 14 group and start our day. Thank you.
- 15 MS. BRYAN: Thank you. I also wanted to just add
- 16 that the HUD staff has heard us asking questions
- 17 repeatedly about, well, how does this impact that in
- 18 terms of the formulas and the way that they're run for
- 19 each tribe. So Ben at HUD has produced or has the
- 20 ability to produce a one-pager. They just happen to be
- 21 plugging in ACS because it's what they have right now.
- 22 But if you really want to see the inner workings of

- 1 one factor change impacts your factors directly, or if
- 2 the Needs Work Group want to entertain this and talk
- 3 more about it in your work group, I did want to let you
- 4 know that there is an opportunity for you to create a
- 5 one-pager for your tribe and to see really how each and
- 6 every factor tweaked by the introduction of a new data
- 7 set, whatever that data set may be.
- 8 So I'm not sure if HUD has more of an explanation
- 9 for this one-pager, but I was grateful to hear about it
- 10 just this morning, and to hear that HUD is listening to
- 11 our concerns. And when we're asking, well, how does
- 12 this impact that, and, how does the introduction of a
- 13 new data set really impact myself or a data run, that
- 14 Ben will be able to -- if you want to sit down with
- 15 him, he can show that to you. So I just wanted to make
- 16 that announcement.
- Any questions or announcements for the good of the
- 18 order before we break?
- 19 (No response.)
- MS. BRYAN: So I think we have some good energy in
- 21 the room. I think people have came with really good
- 22 intentions, and I want you to take those good

- 1 intentions and that good energy into your work groups,
- 2 and let's see what we can come up with. So we're
- 3 dismissed. We'll meet you back here at 5:00 p.m.
- 4 Thank you.
- 5 (Recessed at 9:00 a.m.)
- 6 (Reconvened at 5:09 p.m.)
- 7 MS. BRYAN: All right. If we can all get seated,
- 8 we'll get started back up again. 5:09 p.m., session
- 9 six, Formula Negotiated Rulemaking. Welcome back, work
- 10 group committee members -- work group members, and
- 11 committee members.
- We have an announcement that tonight in the
- 13 Rattler's Room -- Radliffe Room, which is around the
- 14 corner and it has snakes on the doors -- really cool.
- 15 At 5:30, there's going to be a thank you reception from
- 16 the Haliwa-Saponi Indian Tribe and the DDC Construction
- 17 Services out of Navajo to thank us for just being
- 18 partners with them. And so, we'll go to that reception
- 19 tonight. You're all invited. It starts at 5:30 or
- 20 whenever we wrap up here.
- Okay. At this time, we would like to do reports
- from the work groups to the committee. And can we

- 1 please start with Gary Cooper just to switch things up
- 2 from the Needs Work Group?
- 3 MR. COOPER: Thank you, Madam Chair. Needs Work
- 4 Group, of course, as you heard this morning in our
- 5 formal announcement, we had three subgroups that had
- 6 been working beginning last month at session five. So
- 7 we gave those three subgroups a chance to get back
- 8 together.
- 9 Those subgroups were Overlapping Formula Areas,
- 10 and we do have two proposals coming out of that group
- 11 that, I believe, we can bring to the full committee. I
- 12 believe we also have copies, if anyone would like
- 13 those. Those are just some minor changes.
- The first is to add a new paragraph C, and then
- 15 re-letter subsequent paragraphs of 326. And it's just
- 16 to add a paragraph relating to formula area. And then
- other item is, I believe, adding a paragraph in 336,
- 18 paragraph E. And those are both related to the same --
- 19 the same item. So that is something we do have to
- 20 bring forward out of our work group, those two items.
- Our Data Challenges Subgroup looked at several
- 22 different issues, but did not have any recommendations,

- 1 or any changes that needed to be made, or anything to
- 2 bring back to the full work group as far as amendments
- 3 or changes go.
- 4 Our other one, Minimum Funding, is working on
- 5 finalizing a couple of items. It is possible that
- 6 maybe tomorrow we can agree on that concept and draft
- 7 some language behind that. And then it's possible that
- 8 there may be one more item that comes forward out of
- 9 the Overlapping Formula Areas part.
- 10 We did discuss those items today, came back in and
- 11 looked at a number of factors all related to variables.
- 12 And that is where we plan on starting the day at
- 13 tomorrow, starting discussion and seeing if we can get
- 14 anything done and advanced on those items. Those are
- 15 items taken off of our original list. They're all kind
- of related to variables. They are weighting factors,
- 17 selection of variables, extent to poverty and economic
- 18 distress, overcrowding issues, families versus
- 19 household, and housing shortage. That seems to be
- 20 where we will pick up the day and the discussion
- 21 tomorrow in our work group.
- But we do have, like I said, those two items to

- 1 bring forward from our work group, and we do have those
- 2 two items to bring forward. And it's possible that
- 3 tomorrow we may have two more items to bring forward.
- 4 So that is where we're at. I'll leave it up to the
- 5 wishes of the committee as far as when we take up those
- 6 issues. We can take them up later. But just to let
- 7 everyone know that we do have those two items ready to
- 8 bring forward. I believe we have copies of those for
- 9 anyone who would like them. Thank you, ma'am.
- 10 MS. BRYAN: Thank you, Gary. Is there a
- 11 possibility we can get a brief update from the Study
- 12 Group? I understand there was a call in between last
- 13 time and this time.
- MR. COOPER: Yes, ma'am, absolutely. And I would
- 15 be happy to do that. We did have a call just because
- 16 that's what you all asked us to do to formulate a plan.
- 17 We did formulate a plan. I don't have that list in
- 18 front of me right now, but we are working to get
- 19 possibly an item set up on here to post the agenda so
- 20 folks can refer back to it or look at it whenever they
- 21 need to. We discussed four items, and there's four
- 22 items that we will, whenever we can meet this time, we

1 will discuss.

Our plan is to find somewhere, even if we have to

3 meet outside in the parking lot -- no. Find somewhere

4 to meet at 7:00 on Thursday night if not before. It is

5 possible that if the work groups don't need to meet

6 tomorrow evening, and hopefully maybe tomorrow we will

7 find out whether or not that is needed, and maybe we

8 can call for a meeting of the Study Group then.

9 We do have four items that we want to discuss, the

10 first being compiling -- of course we know a list of

11 data sets. So the first would be compiling that list

12 of data sets. The second would be developing a way to

13 evaluate data sets and developing a matrix for that, I

14 think, is number three. And then I think the last

15 item, and don't hold me to it, but I believe that the

16 last item is related to drafting a public notice to

17 call for any data sets that we don't know about.

18 So that is kind of where we're at. We do have a

19 plan in place. Basically we want to -- we've asked the

20 study group members to come prepared -- to have

21 reviewed some items and come prepared for discussion

22 and see what we can -- what we can do and where we can

- 1 to bring, you know, a list of any items that they would
- 2 like to see discussed -- you know, data sources that
- 3 they know that are out there that they would discuss so
- 4 we can start looking at those.
- 5 And then while we're looking at those, also call
- for any that maybe we do not know about it, and try to
- 7 get this done in -- we have roughly 11 months left. So
- 8 we are on track to get that done. So that's where
- 9 we're at.
- 10 MS. BRYAN: Good. Thank you. Sami Jo?
- 11 MS. DIFUNTORUM: Thank you, Gary. I just had a
- 12 quick question, if you guys are able to get out meeting
- 13 notices and information well enough, or is that
- 14 something you need assistance with, if that's all
- 15 working okay?
- 16 MR. COOPER: We're working on that right now. I
- 17 think that maybe possibly we're -- we may be able to
- 18 get that done. We're going to have to see. You know,
- 19 of course with -- I don't want to speak on behalf of
- 20 HUD, but that was kind of my concern originally was,
- 21 you know, I knew that, you know, FirstPic's -- I think
- 22 we all know, you know, FirstPic's contract will be

- 1 ending or, you know, their funding will be ending, I
- 2 guess, for what they're doing, you know, probably at
- 3 the end of this Fiscal Year. So going anywhere beyond
- 4 that, we don't know what we'll be able to do. Bu I
- 5 think, you know, possibly HUD might be able to assist
- 6 us with doing a few different things.
- 7 So I've kind of been trying to work with them to
- 8 see without throwing too much on them. But I think it
- 9 is. It's just real simple -- simple things as, you
- 10 know, do we have someplace that we can post notices and
- 11 post the information for the public. And, of course,
- 12 it makes the most sense that perhaps the website that
- 13 we already use with everything else on it would be the
- 14 place to do that with just setting up a subtem, and
- 15 just small things like that.
- 16 So it's nothing big, nothing major. I think it's
- 17 something we can work through. And hopefully we can
- 18 get through that.
- 19 MS. BRYAN: Thank you. Any other questions for
- 20 Gary, Needs Work Group -- Study?
- 21 (No response.)
- MS. BRYAN: Okay. We'll go on to Jason Adams for

- 1 an update for FCAS.
- MR. ADAMS: Thank you. Good afternoon, everyone.
- 3 Jason Adams, Salish-Kootenai Housing Authority. In
- 4 regards to the FCAS Work Group, we had a lot of work
- 5 done today, good work. And I want to personally thank
- 6 all those folks that did a lot of work between meetings
- 7 here from the last meeting to this meeting. There was
- 8 a lot of email traffic and work done by sub-work groups
- 9 of our group to bring us to where we are today. And
- 10 so, we've got a lot of things moving towards closure,
- 11 and so that's where we're at.
- We started off our morning with a couple of items
- 13 that we were real close on that we wanted to get some
- 14 success on. Item number one on our list was the first
- 15 item that we talked about because this -- the first
- 16 time it came before the committee was at the end of the
- 17 last session. And it's the item of the demolition and
- 18 rebuilding language. And so I think we have 28 minutes
- 19 left on the clock for that item.
- 20 We know that there was not unanimous consent on
- 21 that issue was we ended last meeting, and so we
- 22 addressed some of those issues, and we will be bringing

- 1 back revised language for that. Our group has yet to
- 2 -- we're still drafting that language, and then we'll
- 3 take a look at it again tomorrow. So we're real close
- 4 on that issue.
- 5 And the other issue that we went to is number six
- 6 on our list is unexpended funds. And I guess on our
- 7 list we call it grantee expenditures. And we wanted to
- 8 -- we had a lot of work done, again, between meetings
- 9 on this issue, and so we were able to just pick right
- 10 up with that work that was done, and take a look at the
- 11 language that was proposed.
- 12 There's new sections in three different
- 13 regulations existing. That's going to be changed --
- 14 well, two existing and one new. We have a technical
- 15 correction that was brought up under Section 310.
- 16 There's going to be a change -- just a word change
- 17 there, a correction. Existing language 336 is going to
- 18 have some new sections to it, and a new Section 342,
- 19 which is going to be all new regulation. And so, we're
- 20 -- I think we have -- the 310 language we have
- 21 consensus on. 336 we are close, and 342, we are very
- 22 close. We do have one section that we are going to

- 1 bring forth from 342 that will have dissent coming out
- 2 of the work group. And so, we'll have that for you
- 3 tomorrow hopefully.
- 4 From that, then we went back to our list, and we
- 5 went back to item number two, which is the local area
- 6 cost adjustment factors, and as we had asked for
- 7 previously, you know, the study, I have it in my
- 8 backpack. But the study was, you know, 136 pages long
- 9 or something. And so, we've been asking for kind of a
- 10 synopsis or a presentation on that study, and we were
- 11 able to have that done this morning. And this
- 12 afternoon, Jennifer Ballou was able to do a great job
- in summarizing essentially what that cost study said.
- 14 There's one major recommendation. There were
- 15 several recommendations, but one major recommendation
- 16 came out of that study was to add a new local area cost
- 17 adjustment factor, which is the 515 Program under USDA.
- 18 And so, what the problem is that we have TA
- 19 requests in to basically run a new run -- data run on
- 20 this using that factor. And as I stated last meeting,
- 21 we don't have that information yet from USDA, so we're
- 22 still waiting for that. Once they get the information

- 1 from USDA, then they've got to reconstruct the formula
- 2 run for that. So there's a lot of work behind that,
- 3 and we recognize that's going to probably happen
- 4 sometime this fall.
- 5 What our work group plans to do is bring to you
- 6 draft proposed language under 320 that would include
- 7 this based on that recommendation with the caveat that
- 8 we would not probably seek full committee
- 9 implementation on approval of this without that data
- 10 run. And so, I want to throw back to the committee and
- 11 to the co-chairs that we know that the last meeting
- 12 that's going to happen next August was supposedly
- 13 supposed to just be for the Study Group. We would
- 14 potentially have this one item if the committee agrees
- 15 to it, to allow us to make a final decision on that
- 16 proposed language. You'll see the proposed language,
- 17 but we wouldn't ask for committee approval on that
- 18 until we see the data run that comes out of it.
- 19 So it's kind of a hold harmless provision on those
- 20 items of annual expense level and fair market rent.
- 21 It's adding one more, and so there's going to be some
- 22 adjustments for everybody's grant. And we know how

- 1 that affects everybody, but we'll be hoping that'll
- 2 happen. And again, the language should be ready
- 3 tomorrow for that item.
- 4 The last item we discussed today was -- item
- 5 number three on our list was mutual help conveyance.
- 6 And we have new language under Section 318 that we are
- 7 taking a look at. And we are real close on that
- 8 language also. We should be able to finish our
- 9 discussion. I'm being optimistic hoping we'll finish
- 10 our discussion tomorrow. We have a lot of good
- 11 discussion going on on this issue. It's -- you know,
- 12 there's things that are playing into the discussion,
- 13 our ongoing litigation and some of those things.
- So we acknowledge that, and we want to move past
- 15 that. But I think we're close. Again, being
- 16 optimistic, I think we're close on that item. A lot of
- 17 good work has gone on on that item between the last
- 18 meeting and this meeting.
- And we have two other items on our list, items
- 20 number seven and number nine. And we haven't at the
- 21 work group level been able to discuss those items
- 22 today. But neither one of those items we don't have

- 1 any new language or changes to existing language being
- 2 proposed as of yet. So I'm not sure we'll have too
- 3 much work on those items, but I may be wrong. But I'm
- 4 hoping that and I'm assuming that tomorrow morning when
- 5 we come back to the table here for after the prayer
- 6 time is that will decide how tomorrow goes because the
- 7 agenda currently says that we're going to be in full
- 8 committee in the morning. We are not ready for that
- 9 yet.
- 10 We had a tradeoff in our work group that we
- 11 wouldn't work tonight, but we would work hard tomorrow.
- 12 And if we don't get our work done tomorrow, we will
- 13 work tomorrow night is kind of the tradeoff for our
- 14 work group. It was going to be me and one other person
- 15 possibly tonight. It wouldn't have been a bad thing.
- 16 We'd have got some work done.
- So with that, that's the report out from FCAS Work
- 18 Group. Thank you.
- 19 MS. BRYAN: Thank you, Jason. And if you meet in
- 20 the pool, you'd probably get a bigger turnout this
- 21 evening. So that leads me to -- we'll talk about the
- 22 agenda before we close, but be thinking about the

- 1 question I'm going to propose, and that is how we want
- 2 tomorrow to look before we close this evening.
- 3 We do have order of business here on the agenda.
- 4 That is the public comment period. So I would like to
- 5 open up this part of the agenda for public comments.
- 6 There will be a microphone at end in the back of the
- 7 room, and we invite the public, those of you
- 8 participating in the meetings, if you'd like to come up
- 9 and speak into the public record at this time.
- 10 (No response.)
- MS. BRYAN: And so, I thank you for providing us
- 12 this opportunity to have public comment. And we will
- 13 have this at the end of each day, so please know that
- if you're not ready for your public comments, it will
- 15 be open for you again tomorrow and the following day as
- 16 well.
- So with that, we do have the agenda in front of us
- 18 that says we'll open into full committee in the
- 19 morning. So I'm going to ask the group how you want to
- 20 spend your time, and then how long you will need if
- 21 it's a work group or caucus. Jack?
- MR. SAWYERS: I'd like to call for a caucus with

- 1 our -- in our regions in the morning. I don't think it
- 2 would take more than a half hour, but I think there's
- 3 some questions in the Needs Committee that they wanted
- 4 to talk about. So can we schedule that?
- 5 MS. BRYAN: Yes. Regional caucuses in the
- 6 morning? How does the group feel about that?
- 7 Something we might be needing? Okay. So that could be
- 8 our -- is anybody wanting to jump into full committee
- 9 in the morning? I'm hearing from both groups that
- 10 we're not ready, so we're not ready for that. So we'll
- 11 go into regional caucus from 9:00 to 9:30 or whatever
- 12 that 30-minute mark is, and then go into work groups.
- 13 And what's our anticipated work group time? Do
- 14 you think we could have things ready to come back for
- 15 by what time? What do the work groups need, or do you
- 16 know at this time?
- 17 MR. ADAMS: I laugh because I was telling some
- 18 folks before when I got back from lunch I thought maybe
- 19 we could have everything done by noon tomorrow. And
- 20 then we took one item and spent four hours on it, so I
- 21 don't know. I'm hoping -- again, we left the table
- thinking that we can have our work group work done

- 1 tomorrow. Whether that means just during the day or
- 2 including tomorrow evening, we would have our work
- 3 group work done tomorrow. Who knows, it might happen
- 4 before lunch, but I don't know.
- 5 MR. COOPER: And our work group does have -- I
- 6 think we passed out the two items that came out of our
- 7 work group. You know, we have two more items that
- 8 potentially could come forward, and we just really
- 9 began discussion on another item.
- 10 So I would pretty much say that I will leave it up
- 11 to this committee to tell us when we need to be back
- 12 here from our work group because I think that we can
- 13 probably have some pretty lengthy debate and discussion
- 14 for most of the day.
- 15 MS. BRYAN: Thank you, Gary. And I just want to
- 16 remind all of us that we have two more days of what
- 17 looks -- appears to be eight- or nine-hour days. So
- 18 I'm going to encourage us to push for being back early
- 19 afternoon to get some things done. I just really think
- 20 some things are ready, and we have the opportunity at
- 21 two hours, which is the maximum per item. We're going
- 22 to have to schedule our time pretty wisely. Rodger?

- 1 MR. BOYD: Thank you. I was just actually going
- 2 to say the same thing. We might do a quick tally as
- 3 to, you know, how many different issues or items that
- 4 we are going to negotiate with the remainder of the
- 5 time, times two, which will, I think, give us a clear
- 6 sense of the work that's before us. And I know that
- 7 both groups are working diligently and very hard, but I
- 8 think it's always mindful to keep an idea of how much
- 9 time we have to negotiate.
- 10 MS. BRYAN: Thank you. Carol?
- 11 MS. GORE: I have a suggestion. Thank you. Maybe
- 12 we could ask someone from FirstPic to check in with the
- 13 chairs of the two work groups, check in just prior to
- 14 lunch. And if they're not ready, check in again just
- 15 before the 3:15 break. It would be pretty easy to call
- 16 us back into session if we have someone that's just
- 17 monitoring with the two work group chairs. That's just
- 18 a suggestion.
- 19 MS. BRYAN: Thank you. Yes, Jemine?
- 20 MS. BRYON: I just think one of the other things
- 21 we need to think about is if Thursday is left for most
- of the items to come before the full committee, will we

- 1 have a quorum? Will everybody be here, or will we have
- 2 -- so I just --
- 3 MR. DOLLARHIDE: Our quorum was established this
- 4 morning. So as long as we've got somebody sitting at
- 5 this table to vote, as Jason said, we get a lot of work
- 6 done.
- 7 MS. BRYAN: So I think people will be here.
- 8 They'll want to be here for those decisions.
- 9 MS. BRYON: Cancel those flights.
- 10 MS. BRYAN: We have the beauty of establishing a
- 11 quorum, and then that's it. Be here.
- 12 So that's a good suggestion that -- if FirstPic is
- 13 willing. And Jason and I will get together with Susan
- 14 as well to look at the issues that have been discussed
- in the amount of time and maybe work backwards to see
- 16 what we need to do. Jason?
- MR. ADAMS: To answer Rodger's comment in regards
- 18 to kind of where we're at, we have -- from our work
- 19 group, we have three items that will have language that
- 20 will have the two-hour -- potentially two-hour limit on
- 21 them. And then we have one item that has 29 minutes
- 22 left on the clock. I believe that's what it was. And

- 1 so that's where we're at as of right now.
- Two other items we haven't discussed, and I don't
- 3 know if we'll have anything from those two items. We
- 4 don't have any current thoughts on regulatory language
- 5 existing or new for those two items. So I don't think
- 6 they will have, in my opinion.
- 7 MS. BRYAN: That's helpful information. Thank
- 8 you. Gary, you said two items and potentially one
- 9 other? Did I get that right?
- 10 MR. COOPER: Two items, potentially two other
- 11 items, you know. Based on our discussion, I'm pretty
- 12 confident that, you know -- two items passed this
- 13 morning out of committee. Those are the two items in
- 14 front of you without really -- I mean, with consensus.
- 15 There was no minority possession on those.
- 16 One item they're still working through, but it's
- 17 potential that we could have -- I mean, as of right
- 18 now, I would say it's potential we could have four
- 19 items. So with, you know, with the two-hour time
- 20 limit, that pushes us to eight hours. I don't foresee
- 21 it taking that long, but at the same time, that's where
- 22 we're at.

- 1 MS. BRYAN: So again, I would encourage us to be
- 2 mindful of that in our work groups. And we really
- 3 working backwards need to be in full committee tomorrow
- 4 morning, but I'm hearing we're not ready for that. You
- 5 do have the evening this evening. You have -- you
- 6 know, so people are willing to work tomorrow evening.
- 7 But this is it, folks. This is the time that we have.
- 8 So we'll check back in tomorrow morning, and then go
- 9 from there. Jack?
- 10 MR. SAWYERS: In our caucuses tomorrow, we'd like
- 11 to -- at least I would like to see us look at the
- 12 waiting items for needs, and then get any suggestions
- 13 we can from each region so that we can -- we can work
- 14 through that because that seems to be one of the major
- 15 items that we need to explore. And so, there's
- 16 probably other items also, but that's certainly one of
- 17 them.
- MS. BRYAN: Thank you. Any other questions,
- 19 comments for the good of the order?
- 20 (No response.)
- 21 MS. BRYAN: So next on our agenda to close us out,
- 22 we have Edward Begay from Navajo for the closing

- 1 prayer. We'll see you here in the morning at 8:30.
- 2 Thank you.
- 3 MR. BEGAY: In Navajo, they say that if the first
- 4 time doesn't work, you've got three more -- four tries.
- 5 Good evening, everyone.
- 6 PARTICIPANTS: Good evening.
- 7 MR. BEGAY: The presiding co-chairs, distinguished
- 8 members of the Rulemaking Committee, HUD, and tribes
- 9 throughout Navajo country and Indian country across
- 10 these United States, and also for the HUD officials,
- 11 and other officials that are assembled here.
- Before you in the agenda you have an outline of --
- 13 as I glance over, there's seven tough items with the
- 14 subgroup of four under seven. With the diverse
- 15 practical experience, not only in doing so, but also
- 16 with age of all levels are addressing these items. And
- 17 I sat in a session where everybody take part, and
- 18 ironed out some things that need to be clarified that
- 19 has been on the books for some time, but has been
- 20 silent in clarifying the practical situation in HUD
- 21 funding to Housing Authority's programs.
- In Navajo, tradition, they have what they call a

- 1 prayer bundle, and in there is usually an outline of,
- 2 you might say, agenda for each family. I think it's in
- 3 that nature I describe a little bit about the seven
- 4 items that I alluded to. In a way, it looks like from
- 5 time to time through prayer bundle, they open that
- 6 bundle and review what was blessed in that bundle.
- 7 That's what you are all doing the way I understand the
- 8 process that you have undertaken.
- 9 It takes courage, and it takes love, and it takes
- 10 initiative with vision. That's what I understood. So
- it's always nice to talk about some things that you
- 12 differ on to get it on the table, as they say, which I,
- 13 for one, am appreciative of that. I'd just like to --
- 14 since I've got the floor, I took the privilege of
- 15 public comment.
- 16 (Laughter.)
- MR. BEGAY: With that, shall we all look to our
- 18 Maker, and Creator, and our Savior? I will start my
- 19 prayer in Navajo.
- 20 [NATIVE LANGUAGE SPOKEN.]
- 21 MR. BEGAY: Merciful and kind Heavenly Father, You
- 22 watch over us moment by moment. You give us abundant

- life in which we have an opportunity to be part of an
- 2 ongoing program under the United States Department of
- 3 Housing and Urban Development. Congress appropriates
- 4 money, and they are also appropriated further down to
- 5 each tribe for the needs that have been so long
- 6 outstanding and still lots to come.
- 7 In it, Lord, You provide us guidance through the
- 8 statute, through the guidelines. Oftentimes some of
- 9 the rules have been in place for some time, but now is
- 10 the time to open that up and review by this committee
- 11 -- Rulemaking Committee. Guide us, Lord, with Your
- 12 wisdom, with Your Spirit, to give us kindness, and
- 13 forthright and with vision. We did our work today. We
- 14 pray for Your rest tonight because we've still got work
- 15 to do.
- 16 Forgive us for our shortcomings, and bless us. In
- 17 Jesus' Name. Amen.
- MS. BRYAN: Thank you. We hope to see you all in
- 19 the Radliffe Room.
- 20 (Whereupon, at 5:45 p.m., the meeting was
- 21 adjourned.)
