         Father God, we come to you today, and we ask you

to look down upon the tribes, the families that are

- 1 represented here today. We ask that you come into our
- 2 life and to help us find the way to be closer to you
- 3 and be -- find our way to do the things in our lives
- 4 that pleases you.
- 5 As we move on to this conference, Father God, we
- 6 ask that you open our hearts and our minds that we can
- 7 find a way to come together and do what's best for our
- 8 people on a path to our God.
- 9 And in closing, Father, I ask you that whatever
- 10 needs are here today, represented here today --
- 11 illnesses, worries that people have about death of a
- 12 neighbor back home -- that you take care of them for
- 13 us, Father God.
- We ask these things in your name, amen.
- 15 (Pause.)
- MS. BRYAN: Good morning. Thank you all for
- 17 coming. And as Jason said, looking forward to a
- 18 productive Denver meeting session.
- 19 And next on our agenda is the welcome by Jemine
- 20 Bryon, the Acting Assistant Secretary for Public and
- 21 Indian Housing. Good morning, and welcome to our

- 1 table.
- MS. BRYON: Good morning, everyone. And welcome
- 3 to our fifth meeting of the HUD IHBG Formula Negotiated
- 4 Rulemaking Committee meeting.
- 5 I would like to extend a special welcome to the
- 6 tribal leaders who are here with us today and thank
- 7 them for making housing a priority issue among all
- 8 those you face every day in your nations and
- 9 communities.
- 10 My name is Jemine Bryon. I am the Acting
- 11 Assistant Secretary for Public and Indian Housing. I
- 12 have the honor of following behind Ms. Henriquez, who
- 13 has done a wonderful job to date in working with you,
- 14 and I look forward to carrying on that wonderful
- 15 success that she has had.
- 16 I'm -- my official title is the General Deputy
- 17 Assistant Secretary for Public and Indian Housing, but
- 18 (inaudible) totally replaced me. I've dedicated my
- 19 career to working on ways to provide quality affordable
- 20 housing to communities in need, and you have my
- 21 commitment to continue these efforts in the area of

- 1 Indian housing. I am honored to be the new HUD
- 2 committee member and look forward to working with the
- 3 tribal nations on a government-to-government basis.
- 4 I was in attendance at the last committee meeting
- 5 in Phoenix in June and saw firsthand the incredible
- 6 effort and passion that you all have of the committee
- 7 members to tackle these very tough issues and address
- 8 the concerns of your fellow committee members. While I
- 9 was encouraged to see the commitment of members to come
- 10 here in good faith, I also became concerned that the
- 11 committee has not yet engaged in negotiations.
- 12 As my predecessor, Assistant Secretary Henriquez,
- 13 has raised at every meeting, we are uncertain what the
- 14 future holds as far as funding. We are facing a tough
- 15 climate with a possibility of sequester cuts in '15 or
- 16 '16.
- 17 I say all of this to once again emphasize how
- 18 crucial it is that we make the most of these last two
- 19 NegReg sessions and for you to use your voice as
- 20 representatives of the tribal nations across the
- 21 country by bringing forward your recommendations. I'm

- 1 really excited about these opportunities, and I look
- 2 forward to working with you to progress in this area.
- 3 So thank you very much.
- 4 MS. BRYAN: Thank you, and welcome.
- 5 Next we'll have logistics from Sara.
- 6 MS. FIALA: Hi. Good morning, everybody. Oh,
- 7 sorry. Just really quickly, I'm going to go over just
- 8 some basics of the hotel. You all found it here this
- 9 morning. That's good. I know it was a little tricky
- 10 to find, but everything else looking out should be very
- 11 easy.
- 12 We happen to have this floor and the floor above
- 13 are completely for our group. So all the meetings are
- 14 either here. There's one breakout room, Vail, across
- 15 the hallway, and upstairs on the next level -- just
- 16 take the escalator -- are the other breakout rooms.
- 17 The room assignments, temporary room assignments,
- 18 you can see them up on the board for the workgroups and
- 19 the caucus rooms. The FCAS group will be meeting in
- 20 the Vail Room, which is right around the corner on this
- 21 level. The other rooms are above the escalator.

- 1 And then for those of you that need Wi-Fi log-in
- 2 information, it's FIRSTPIC33, all caps. That's the
- 3 user name and the password. So just click on Sheraton
- 4 Meetings, and then you can enter in your user name and
- 5 password.
- 6 As always, we have staff throughout the meeting
- 7 space. So if you have any questions or any issues,
- 8 please let us know.
- 9 Thank you.
- 10 MS. BRYAN: Thank you, Sara. And thank you all
- 11 for the hard work, for pulling it together. It's a
- 12 little different just coming here, so appreciate you.
- 13 Next on the agenda, we're going to go over the
- 14 committee review and approval of the group host agenda.
- 15 So that's in front of you. Are there any additions or
- 16 changes to the agenda as you look at it right now this
- 17 morning?
- 18 (No response.)
- 19 MS. BRYAN: So we had scheduled to just do a brief
- 20 update on what the committees are doing, and then we're
- 21 going to break at -- into workgroups at 9:45 a.m. and

- 1 just hit it. And then we'll do the same for tomorrow,
- 2 too. We'll get together and break into workgroups.
- 3 So, again, I want to make it flexible with this.
- 4 Jemine?
- 5 MS. BRYON: Hi, I apologize. I do want to speak
- 6 to the agenda. As you know, HUD has formed a strong
- 7 partnership with the Census Bureau, and through this
- 8 partnership, we have learned that the Census ACS has
- 9 endless possibilities in addressing your concerns.
- 10 Since we have not had a chance to discuss this in depth
- 11 with the Census Bureau, they have agreed to be present
- 12 at today's meeting.
- 13 Therefore, in our draft agenda provided to the
- 14 committee and workgroup co-chairs, HUD proposed placing
- 15 the Census folks on today's agenda to provide
- 16 additional insight into the Census ACS and to discuss
- 17 several of the TA requests. After much discussion, the
- 18 chairs and co-chairs decided to move this presentation
- 19 from the plenary session to the needs workgroup.
- 20 However, given the importance of this issue and
- 21 HUD's role in providing TA to the group, I will be

- 1 proposing that the full committee consider adding it
- 2 back to today's agenda. I consider the Census Bureau
- 3 presentation to be that important.
- An understanding of what the Census Bureau can
- 5 provide us is a basic foundation to build on as we
- 6 develop solutions to these formula concerns and
- 7 directly respond to questions asked by committee
- 8 members. If this presentation is moved to the needs
- 9 workgroup agenda, I am concerned that it is unfair to
- 10 ask the FCAS subcommittee members to choose between two
- 11 very important agenda items, especially since the full
- 12 committee will ultimately be making decisions on this
- 13 issue.
- 14 Please know that I make this proposal in good
- 15 faith, believing that this will prove to be an
- 16 efficient use of our limited time as it will ensure we
- 17 are all aware of the Census ACS capabilities and
- 18 limitations. I thank you very much for your
- 19 consideration of this proposal, for your service to
- 20 this committee, and to your service to American Indians
- 21 and Alaska Natives in need of housing assistance.

- 1 MS. BRYAN: Thank you. I'm glad that you brought
- 2 that up. There was a long discussion.
- 3 When planning these agendas, we have to guess what
- 4 might be in the best interest of the committee. So I'd
- 5 like to open it up to the committee to hear your input
- 6 on the presentation that has been prepared for us
- 7 through a TA request for the committee today.
- 8 Jason?
- 9 MR. ADAMS: Good morning, everyone. Jason Adams,
- 10 Salish Kootenai Housing Authority.
- 11 First and foremost, I'd just like to, on behalf of
- 12 the UNAHA region and as the UNAHA chairman, welcome you
- 13 all to the Northern Plains region here. And I just
- 14 wanted to speak up in regards to the agenda and Ms.
- 15 Bryon's comment with regards to any presentations
- 16 today.
- 17 I was the one that spoke against any type of
- 18 presentations on the agenda for the full committee,
- 19 this one and there was another one that was proposed,
- 20 mainly for two reasons. First and foremost, being a
- 21 workgroup chair, our workgroup has tried to get through

- 1 work. As the Assistant Secretary had mentioned her
- 2 concern about getting to negotiations, our workgroup is
- 3 trying to get there.
- 4 Our workgroup is working on proposals that we will
- 5 bring items back to the table for the full committee to
- 6 consider here very soon. And hopefully, that will
- 7 happen by, as you see on the agenda, Friday. That's
- 8 being very optimistic that we get there. We've got a
- 9 lot of issues to work on.
- 10 And so, my first and foremost priority is getting
- 11 back into our workgroups so that we can get the work
- 12 done that we've been charged to do. There's a lot of
- 13 folks throughout the country that participated in the
- 14 process to set the parameters of our work here that
- 15 asked for things to be considered, things to be
- 16 revised, things to be looked at through the workgroup
- 17 and through this committee, and I just think it
- 18 behooves us to get there to work on those issues.
- 19 And our workgroup, as they appear here in a few
- 20 minutes, has a lot of work to get done. We've been
- 21 very diligent in trying to keep with our timeframes and

- 1 get some product to this committee. And so, that's
- 2 really the first issue that I raised on the point here.
- 3 The other -- the second issue is really just the
- 4 idea of ACS. We need to have -- well, as we worked on
- 5 at our last meeting, there was the approval of this
- 6 committee to a proof of concept of a study group to
- 7 study datasets.
- 8 And to me, all of those questions that have gone
- 9 unanswered are really issues that need to be raised and
- 10 need to be addressed in the study workgroup that's
- 11 going to happen and going to take place over the next
- 12 year, as per the concept document. So I would hope
- 13 that we would leave those issues that are dataset
- 14 related to that workgroup and that study time for the
- 15 next year.
- 16 So that's really my concern is that, first and
- 17 foremost, again, that we take this time and get right
- 18 into our workgroups and start working on those issues
- 19 to come back to the table to negotiate on those issues
- 20 that we can negotiate on. I think everybody
- 21 acknowledges that the study -- the dataset issue is a

- 1 huge issue and needs a lot of time. That's why the
- 2 additional time has been -- has been granted in
- 3 concept, and I'm very appreciative of that opportunity.
- 4 So, hopefully, we can stick with that. Again, I
- 5 just wanted to explain my objection to the draft agenda
- 6 that was proposed that had quite a bit of time set
- 7 aside for an ACS presentation. So, hopefully, I've
- 8 helped explain that, that opposition this morning.
- 9 Thank you again.
- 10 MS. BRYAN: Thank you, Jason. Jemine and then
- 11 Earl.
- MS. BRYON: Again, let me just not ignore
- 13 commending the committee for the vote that took place
- 14 at the last meeting to have a 2-year delay on the
- 15 implementation of a dataset and the work surrounding
- 16 the concept of the study. I look forward to discussing
- 17 the concept of the study and the parameters such as
- 18 cost, time, and participation.
- 19 However, again, the presentation that we are
- 20 referring to from the Census Bureau is really to form
- 21 the foundation of any discussions that the work -- the

- 1 needs working group will enter into. It is a very
- 2 informative, broad conversation about what is
- 3 available, what can be done, and the role that the
- 4 Census Bureau has taken over time and can take in the
- 5 future to assist us in our formula.
- 6 So, again, that is why we are proposing that it be
- 7 added to the agenda for the full committee.
- 8 MR. EVANS: First of all, welcome, Ms. Bryon --
- 9 MS. BRYON: Thank you.
- 10 MR. EVANS: -- to the committee. Or welcome,
- 11 congratulations, or condolences, whichever applies.
- 12 (Laughter.)
- MS. BRYON: I take the former.
- 14 MR. EVANS: My question concerning the proposal of
- 15 the ACS presentation is this. Based on what you've
- 16 described, it sounds like the information we've already
- 17 been provided at earlier meetings. So my question
- 18 would be how would you see the presentation that you're
- 19 proposing as being different than the presentations
- 20 that we've already received and instead of being a
- 21 regurgitation of the same information that's been

- 1 provided?
- MS. BRYON: So we do have a Census representative
- 3 here. Perhaps they could answer your question as far
- 4 as what the difference is between their presentation
- 5 this time and last time. Can you allow them to do
- 6 that? Just 2 minutes.
- 7 MS. BRYAN: I'd say 30 seconds maybe.
- 8 MS. BRYON: Thirty seconds. You'll be given 30
- 9 seconds.
- 10 MR. TREAT: So, good morning, everyone. I'm Jim
- 11 Treat. I'm from the Census Bureau.
- 12 What we're planning to do is really have more of a
- 13 conversation rather than a presentation. I know at the
- 14 meetings that we had in March, we ran out of time, and
- 15 the committee had a lot of questions.
- So, one, it's a more dialogue-focused session, as
- 17 well as there were questions that the committee
- 18 submitted through HUD to us that we were trying to
- 19 address some of those questions in the information that
- 20 we wanted to relay.
- 21 Thank you.

- 1 MS. BRYAN: Thank you. Yes, Jack? And then
- 2 Rodger.
- 3 MR. SAWYERS: We follow our procedure. We have
- 4 had a presentation. We do have questions. All of
- 5 those things will be forwarded to our committee when we
- 6 study through this year.
- 7 And so, I -- I think it's, in my opinion, not a
- 8 waste of time, but we certainly have other things to do
- 9 before we get in -- we're here to get a whole year of
- 10 study. This is part of that. And so, I would say
- 11 let's delay until the study begins.
- MR. BOYD: Thank you, and good morning.
- One of the things I'd like to add into this is
- 14 that we've had 26, I believe, TA requests over the last
- 15 several months. And what we are also trying to do, and
- 16 I think as the gentleman from Census alluded to, is
- 17 that we wanted to also tie in some of these TA requests
- 18 into that presentation so it'd give everybody an
- 19 opportunity to see the results and the impact that some
- 20 of these TA requests would have.
- 21 I think sitting in some of the needs working

- 1 groups, I think we certainly have circled around ACS,
- 2 but we have never really gotten into a position of
- 3 looking at some of the benefits. And -- and so, we
- 4 felt that some of these TA requests that were made
- 5 could be presented and talked about at that time.
- 6 Thank you.
- 7 MS. BRYAN: Thank you, Rodger.
- 8 I'm going to take a minute, if I can. We'll call
- 9 on Carol. And then, just logistically, roll call
- 10 wasn't on the agenda. So I skipped over it. For the
- 11 record, before we do vote on the agenda, we'll need to
- 12 do a roll call.
- 13 So, Carol?
- MS. GORE: Thank you. I think it's clear that the
- 15 agenda for the committee will not reach consensus to
- 16 change what's already been presented, right? But I
- 17 want to speak in favor of the Census group making a
- 18 presentation to the needs workgroup.
- 19 There are really two things I think that matter to
- 20 all of us. One is that the study group framework has
- 21 not been considered yet by the needs workgroup. How we

- 1 get to that means we have to understand where the
- 2 challenges are not just with ACS, but others. The same
- 3 challenges we face with ACS we'll face with any
- 4 dataset. So I think this educational component will be
- 5 really helpful.
- 6 The second reason I think it matters to us is
- 7 because Census has asked us for our input. We're
- 8 looking at a 2-year transition period, I think, whether
- 9 it's ACS or a different dataset. ACS is being used in
- 10 Indian Country. Our input matters not just to our
- 11 formula if ACS is the dataset -- I'm not suggesting it
- 12 is. But it will matter to Indian Country that Census
- 13 hears from all of us.
- 14 And within a 2-year period, they have a chance to
- 15 improve how they collect our data, I think that's
- 16 important. I think that's worthy of a couple of hours
- 17 from the needs workgroup to listen to them.
- 18 So I'm speaking in favor of them presenting today,
- 19 whether it's at the committee or at the needs
- 20 workgroup, and not deferring it to the study workgroup.
- 21 I personally would benefit from hearing that

- 1 information because the framework of the study group
- 2 has not been determined yet, and we have a lot that's
- 3 circular to date to have about that framework. This is
- 4 helpful to me. So I speak in favor of that.
- 5 Thank you.
- 6 MS. BRYAN: Thank you. So I think it's good to
- 7 hear those things. And Census Bureau, stand by. You
- 8 are not off the hook.
- 9 So I'm going to go ahead and do roll call, and
- $10\,$  we're going to take vote on this agenda. And we'll
- 11 just start with Jack, if you could? Your name and
- 12 where you're from for the official record, please?
- MR. SAWYERS: Jack Sawyers, Utah Paiute,
- 14 representing Region 5.
- MR. ADAMS: Good morning. Jason Adams, Salish
- 16 Kootenai Housing Authority.
- 17 MR. SHURAVLOFF: Good morning. Marty Shuravloff,
- 18 Kodiak Island Housing Authority.
- 19 MS. NUTTER: Good morning. Teri, with Copper
- 20 River Housing Authority.
- 21 MS. GORE: Good morning. Carol Gore from Cook

- 1 Inlet Housing.
- MS. CLOUD: Hi, everybody. Heather Cloud, Ho-
- 3 Chunk Nation.
- 4 MS. FLOOD: Deirdre Flood, Washoe Housing
- 5 Authority.
- 6 MR. THOM: Michael Thom, Karuk Tribe.
- 7 MS. DIFUNTORUM: Good morning. Sami Jo
- 8 Difuntorum, Siletz Tribe, Region 6.
- 9 MR. EVANS: Earl Evans, Haliwa-Saponi Indian
- 10 Tribe.
- 11 MR. DOLLARHIDE: Jason Dollarhide, Peoria Tribe.

- 13 Authority.

- 1 MR. OKAKOK: Samuel Okakok, Native Village of

- 3 MS. FOSTER: Good morning. Karin Foster, Yakama
- 4 Nation Housing Authority.
- 5 MS. BRYON: Jemine Bryon, Department of Housing
- 6 and Urban Development.
- 7 MR. BOYD: Rodger Boyd, HUD ONAP.
- 8 MR. COOPER: Gary Cooper, Housing Authority of the
- 9 Cherokee Nation.
- 10 MS. HOBGOOD: Robbie Hobgood. I'm sitting in for
- 11 Russell Sossamon with Choctaw Nation.
- 12 MR. HAUGEN: Lafe Haugen, Northern Cheyenne Tribal
- 13 Housing Authority.
- MS. BRYAN: Okay. We have a quorum to conduct
- 15 business. Thank you very much for indulging me there.
- 16 Now we have a proposal on the table to amend the
- 17 agenda to include the Census Bureau presentation.
- 18 All in favor? The proposal has been made. We
- 19 need to vote. So who would like to hear the
- 20 presentation in full committee? Thumbs up, thumbs
- 21 down, sideways, backwards, anyone? Everyone?

- 1 (Voting.)
- 2 MS. BRYAN: Okay. It is not passing. We had an
- 3 alternative presented that we went into our workgroups.
- 4 So I'm just going to go ahead and move this vote
- 5 forward to have the proposal for the Census in the
- 6 needs workgroup and so that the FCAS workgroup can
- 7 separate and do their work.
- 8 Rodger?
- 9 MR. BOYD: We would -- sorry. We would like this
- 10 presentation then to the needs working group be made in
- 11 this room since it's already set up. I think it'd be -
- 12 visually, I think it would be very helpful. And we
- 13 would like to open this presentation to all committee
- 14 members that want to attend and to the public that
- 15 would like to attend.
- 16 Thank you.
- 17 MS. BRYAN: Thank you, Rodger. Earl? Marty, then
- 18 Earl.
- 19 MR. SHURAVLOFF: Thank you. I just want to
- 20 mention if -- and I think Rodger pretty much answered
- 21 my question, but if you're going to have this

- 1 presentation, I would like to know what time and when
- 2 so we can attend this.
- 3 MS. BRYAN: Absolutely. Earl?
- 4 MR. EVANS: Thank you. Earl Evans, Haliwa-Saponi.
- 5 I'm a little confused. I think the vote that we
- 6 just had was that we voted to approve the agenda. That
- 7 was about not getting into the full -- we should be
- 8 separated. So do we --
- 9 MS. BRYAN: The vote was to amend the agenda, and
- 10 that vote got voted -- there was not a consensus for
- 11 it. So I would like to propose the agenda as it stands
- 12 for us.
- 13 MR. EVANS: So then my next question is do we need
- 14 to vote for that presentation to occur in the needs
- 15 workgroup, or is that simply left to the discussion of
- 16 needs --
- 17 MALE SPEAKER: Needs.
- MR. EVANS: Okay, thanks.
- 19 MS. BRYAN: My opinion on the answer to that
- 20 question is that they were invited to come when we had
- 21 the conference call creating the agenda, that they

- 1 would stay and present to the needs workgroup as it is
- 2 critical that we hear these presentations and have
- 3 these conversations with the work that we're doing in
- 4 that workgroup.
- 5 So all in favor of the agenda as it's proposed?
- 6 (Voting.)
- 7 MS. BRYAN: Thank you. We have an approved
- 8 agenda.
- 9 Next is our approval of the minutes from our
- 10 fourth session, which was June 11th through the 13th in
- 11 2014.
- 12 Marty, is your card still up?
- MR. SHURAVLOFF: No.
- MS. BRYAN: Okay. Rodger?
- MR. BOYD: I wanted to respond to Marty's comment.
- 16 What we would like to do as the respective working
- 17 groups break out into their respective areas that the -
- $18\,$  we make this presentation at that time, which would
- 19 be this morning, to the needs working group.
- 20 MS. BRYAN: Thank you. We are going to be ahead
- 21 on the agenda. So at that time, if we do break out

- 1 into workgroups early, you can stay and listen to the
- 2 presentation.
- 3 So next on the agenda is approval of the minutes.
- 4 MS. GORE: Madam Chair, Carol Gore. I move to
- 5 approve.
- 6 MS. BRYAN: We have a move to approve.
- 7 MR. EVANS: Earl Evans. I second.
- 8 MS. BRYAN: We have a second. All in favor of
- 9 approving the minutes from June 11th through the 13th?
- 10 (Voting.)
- 11 MS. BRYAN: The minutes have been approved. Thank
- 12 you.
- Next on our agenda is the FCAS and needs
- 14 workgroups review, and we have Jason Adams for the FCAS
- 15 workgroup.
- MR. ADAMS: Good morning. Jason Adams, Salish
- 17 Kootenai Housing Authority.
- 18 On behalf of the FCAS workgroup, I just wanted to
- 19 give a brief overview of where we've been and what we
- 20 are working on. As I've stated in the past, we have
- 21 nine items that were part of the overall master list of

- 1 issues. We boiled those down to nine areas that we are
- 2 working on currently.
- 3 The first item on our list was the language in
- 4 regards to demolishing units and rebuilding those
- 5 units. And that language is actually ready to come to
- 6 the floor for full committee consideration whenever we
- 7 have that opportunity.
- 8 Item Number 2 on our list was the Indian Housing
- 9 Operating Cost Study and looking at a -- there was a
- 10 study done. Actually, this issue was related to the
- 11 AEL and those local area cost adjustments. And there's
- 12 a TA request out there for that issue. There was a
- 13 study that was done in 2008, and our workgroup was --
- 14 hopefully, everyone has had time to digest that study
- 15 and look at its recommendations. That's going to be
- 16 probably where we start our workgroup today is with
- 17 that issue.
- 18 Number 3 on our list is the Mutual Help
- 19 conveyance, and we have a sub-workgroup that's working
- 20 on some language for that.
- 21 Number 4 on our list was the Section 306 of the

- 1 regulation, (c), in regards to Section 8 units. And we
- 2 have a technical correction issue there that we're
- 3 going to propose. Also from that work, there was a new
- 4 issue that came about with conversion of units and how
- 5 they get counted after they're converted. So we're
- 6 working on that issue.
- 7 Number 5 on our list was FCAS with no needs or low
- 8 needs money, and we have some TA requests in for that.
- 9 I think we have three TA requests in and that those are
- 10 ready for our discussion now.
- 11 Number 6 on our list was put a time limit on
- 12 grantees' expenditures, no-year money in regards to the
- 13 appropriations language from 2012. Current language
- 14 that's being considered in the President's budget
- 15 request and through appropriations, and so we're having
- 16 -- continuing our discussions on that issue.
- 17 Number 7 on our list is Section 302(c) in relation
- 18 to FCAS, and that's, again, from the statute and some
- 19 other parameters as far as maybe some additional
- 20 parameters as far as how money in the formula is
- 21 granted to tribes.

- 1 The last two issues on our list we didn't get to
- 2 talk about yet in our workgroup. All seven that I've
- 3 previously discussed, we've actually had discussions in
- 4 all of these areas so far and hope to get back to the
- 5 six that remain from those and come up with some
- 6 proposals for the full committee.
- 7 The last two areas that we are going to try to get
- 8 to and discuss are HUD processes and practices that
- 9 could be in conflict with proposals, and that was an
- 10 early TA request that showed all of the HUD notices and
- 11 guidances. And what I mentioned earlier in regards to
- 12 the new issue on conversion and count of units, that
- 13 actually is contained in the current guidance, that we
- 14 are going to possibly come back with some language
- 15 based on that guidance to put it in the regulation
- 16 where it should be.
- 17 And the last issue, Number 9 on our list, is
- 18 NAHASDA assisted units. We are all looking forward to
- 19 getting to that issue and having a very lively
- 20 discussion on that issue when we get there.
- 21 So those are the nine areas that the FCAS

- 1 workgroup is trying to get through. On behalf of all
- 2 of the -- all of the folks that listed items on the
- 3 overall matrix when we started this process, we're
- 4 trying to come up with language to come back to the
- 5 full committee to perform and negotiate on, hopefully
- 6 at least by our last meeting in Scottsdale.
- 7 So as far as an overview of where the FCAS
- 8 workgroup is, that's what I have for you this morning.
- 9 Thank you.
- 10 MS. BRYAN: Good. Thank you, Jason.
- 11 Overview on the needs workgroup. Sami Jo
- 12 Difuntorum?
- MS. DIFUNTORUM: Good morning. Thank you. Sami
- 14 Jo Difuntorum.
- 15 In needs workgroup, we touched on three items
- 16 primarily. The first was discussion on some of the
- 17 challenges and identification of the problems. And the
- 18 problems were identified was the need to expand the
- 19 challenge timeframe and the data collection procedure.
- 20 The discussion resulted in the workgroup
- 21 submitting a TA request for the number of Census

- 1 challenges submitted by tribes, the number of 2 challenges initiated by HUD, the number of successful
- 3 and unsuccessful challenges and the number withdrawn,
- 4 the primary reasons for approval, and the primary
- 5 reasons for denial. We did receive the TA request, and
- 6 I have a copy of that for the workgroup to look at when
- 7 we break back into the needs workgroup.
- 8 There was a discussion on two concepts that were
- 9 presented to the full committee. The workgroup
- 10 ultimately divided into one workgroup and one drafting
- group to further develop the concepts. One is the
- 12 reimplementation of a new data source called the
- 13 volatility clause. I think of it as the "nuclear
- 14 option," but it's really not that.
- 15 (Laughter.)
- MS. DIFUNTORUM: The discussion resulted in the
- 17 drafting of a potential rule that would mitigate the
- 18 impact to tribes that would lose money as a result of
- 19 the introduction of a new data source in FY <u>'18</u>
- 20 The other group was the study group. The subgroup
- 21 was tasked with developing a framework for a group that

- 1 will study data sources to use in the needs portion of
- 2 the grant to include practicality and methodology for
- 3 conducting a qualitative analysis.
- 4 Some of the questions -- and I don't know if
- 5 they're answered yet. I wasn't part of that particular
- 6 group. We divided. Who will participate? Where will
- 7 the meetings take place? Who will pay for the
- 8 meetings? Look for and associate a cost timeframe.
- 9 It's really a pretty big task, and it's a pretty
- 10 big subject. So I anticipate that will be a subgroup
- 11 when we break back into the workgroup.
- 12 My preference, and I'm stepping out of my role of
- 13 chairing the needs workgroup. I think it's a conflict
- 14 with another commitment, and so what we will be doing
- 15 is selecting new chairs and co-chairs for the
- 16 workgroup.
- 17 I did prepare a draft agenda for the workgroup,
- 18 and what I had anticipated is the ACS presentation to
- 19 the study group. It will be up to the workgroup if the
- 20 whole workgroup wants to hear the presentation or not.
- 21 And then tomorrow morning, there will be a presentation

- 1 on overlapping formula areas.
- 2 It seems to me, given the limited amount of time
- 3 that we have and the amount of time that the study
- 4 group is going to take to develop that we really need
- 5 to have a group that's looking at some of the other
- 6 issues that we can handle without having the data
- 7 source identified by formula areas and things in the
- 8 regulations along those lines.
- 9 So that's where we've been. That's where we're
- 10 going. Thank you.
- 11 MS. BRYAN: Thank you, Sami Jo. Jason?
- 12 MR. ADAMS: Yeah, Madam Chair, thank you. Co-
- 13 Chair. I just -- Jason Adams, Salish Kootenai.
- 14 I wanted to -- since we are ahead a little bit on
- 15 the agenda, I have a request from a member from our
- 16 region to have a few minutes just to speak. And he's a
- 17 good friend of ours, good friend of many in this room,
- 18 a well-respected tribal leader for years, worked in
- 19 housing for many years.
- 20 And he'd asked for just a minute of time for this
- 21 morning. So, as a committee member, I'd like to yield

- 1 a few moments of time to my friend Paul Iron Cloud.
- If a mike could be brought to Paul, that would be
- 3 great. Thank you.
- 4 MR. IRON CLOUD: Do I have to holler?
- 5 (Laughter.)
- 6 MR. IRON CLOUD: Thank you very much for yielding
- 7 me some time for this very, very important group. I
- 8 feel that you guys are doing something that's probably
- 9 been needed for a long time, and I just wanted to greet
- 10 everybody with a warm handshake here today.
- It's been a while since I've been coming to these
- 12 meetings. I know I was on the first Negotiated
- 13 Rulemaking Committee 17 years ago, and we were talking
- 14 about at breakfast this morning just a comment. We
- 15 were at 600 million then, and we're still at 600
- 16 million. So that's 17 years, and our population has
- 17 grown, grown.
- 18 And here's one of the poorest counties in the
- 19 United States of America. You try to make things where
- 20 our population is growing. We have 45,000 people and a
- 21 budget of \$11 million. Well, that isn't very much

- 1 after you look at your maintenance and all of the
- 2 things that you've got to do. Every one of you that's
- 3 been a housing director knows how important it is to
- 4 have dollars to do the job that you want to do.
- 5 But you know I was very, very -- I don't know how
- 6 to say it. I'm scared of what's going to happen where
- 7 we're going to go with this American Community Survey,
- 8 and maybe to some it's good. But if you look at our
- 9 tribes in our region, see how we operate, come and
- 10 visit. Two, three families living in one house.
- 11 Rodger Boyd was there. I had appropriations
- 12 people there last summer, House Appropriations. I had
- 13 10 people there who walked through these homes to
- 14 actually see what I was talking about. Every time I go
- 15 to Washington, they're probably tired of hearing my
- 16 same story, but that's reality. That's really
- 17 happening.
- 18 We have some other problems. We've got drugs.
- 19 We've got meth. We've got everything that's out there
- 20 is there, and you have a limited budget we work with.
- 21 Just put yourself in my position one time.

- You know, I had a friend come and see me, and I'm
- 2 really proud of him. And that was Jack Sawyers. He
- 3 came to Pine Ridge and actually looked through the
- 4 homes and looked at the need that was there.
- 5 And I also want to thank Jason Adams, who's been a
- 6 longtime friend of mine. He's been within HUD for so
- 7 many years. He knows Indians. He's no different from
- 8 us.
- 9 But I'll tell you what. You look at Sharon Vogel
- 10 here. She has one of these tough times, just like I
- 11 do. You've got Rosebud. You've got one of those big
- 12 tribes. I feel a great need, and I could lose
- 13 \$700,000.
- 14 Our road conditions are bad. They're going to
- 15 take some of that money. I think we really have to sit
- 16 down and think where is the need? And I think that's
- 17 what you're doing here.
- 18 You know, I think I used to tell the Senators when
- 19 I was tribal chairman at one time at Pine Ridge. I was
- 20 on the council for 16 years. And I used to always tell
- 21 them you need to actually come there and see what I'm

- 1 talking about.
- 2 You know, our law and order, when I was there, we
- 3 had 100 police officers. Right now, we have 38 police
- 4 officers to govern 80 by 100 miles. Now you tell me
- 5 how we're going to do that.
- 6 These are just some of the things that I see every
- 7 day that there's a need, and that's why I'm here today
- $8\,$  to thank you guys for doing what you did, looking at a
- 9 new study. It's going to be very, very important to
- 10 some of our tribes, Northern tribes.
- 11 So I don't want to take any more of your time, but
- 12 hope that I gave you a message, and I'm speaking from
- 13 the bottom of my heart here today to convince some of
- 14 you that there is a real, real need out there.
- 15 Thank you very much.
- MS. BRYAN: Thank you.
- 17 (Applause.)
- 18 MS. BRYAN: Thank you, Mr. Iron Cloud, for all
- 19 your years of dedication. And I think you speak for
- 20 each and every one of us when you say that, you know,
- 21 our reservations are some of the poorest places in the

- 1 country. Each and every reservation, each and every
- 2 tribe, each and every village has some very, very
- desperate conditions. So thank you for bringing that
- 4 awareness, and we're all in that same situation.
- 5 And there will be more time at the end of the day
- 6 for public comments, people want to continue to share
- 7 and lend those important details to the public record
- 8 for this negotiated rulemaking.
- 9 So we are now on the agenda, I would like us to
- 10 break into workgroups, and the needs workgroup is going
- 11 to be here. And we will let the needs workgroup
- 12 decide, but if you're interested in hearing the
- 13 presentation and you do have extra time, I would hope
- 14 that the needs workgroup would entertain letting the
- 15 Census Bureau give their presentation when we leave or
- 16 starting after the break.
- 17 So we'll have a 15-minute break, start here at
- 18 9:30 a.m. That's 14 minutes, I guess, technically.
- 19 And if we could -- I think we're getting the needs
- 20 workgroup and the FCAS workgroup rooms up on the screen
- 21 for you. I'll let Sara or someone from FirstPic

- 1 announce where we're going to be for those workgroups.
- 2 Thank you.
- 3 MS. FIALA: The needs workgroup will be here, and
- 4 the FCAS workgroup will in the Vail Room, which is go
- 5 out this door and it's straight back.
- 6 (Recessed at 9:17 a.m.)
- 7 (Reconvened at 5:06 p.m.)
- 8 MS. BRYAN: Thank you all for coming back. We'll
- 9 go ahead and get started. It's 5:06 p.m., and we have
- 10 a lot of work that's been accomplished today.
- 11 So I would like now to start with an announcement
- 12 just so I don't forget. I know the needs workgroup on
- 13 the Web site, the BIA information has been put up
- 14 there. So those of you who requested it know what it
- 15 is, and it is there available for you now.
- 16 The reports from the workgroup to the committee.
- 17 We're going to start with Jason Adams with FCAS.
- 18 MR. ADAMS: Good afternoon. Jason Adams, Salish
- 19 Kootenai Housing Authority.
- 20 On behalf of the FCAS workgroup, everything we
- 21 told you this morning we were going to do, we're done.

- 1 So we're good.
- 2 (Laughter.)
- MR. ADAMS: Almost. We're getting there.
- 4 We had a good session today. Going back through
- 5 the -- we have nine issues, essentially nine areas. I
- 6 shouldn't say specific issues because some of these
- 7 areas have a lot of different issues within them. But
- 8 we have nine items that were taking a look at today.
- 9 As I did report this morning, we are ready on Item
- 10 Number 1 on the demolition language. That language is
- 11 actually out there from our workgroup session last
- 12 meeting.
- 13 So if you want to take a look at that, any of the
- 14 committee members, before we negotiate on that
- 15 language, it is currently out there in draft form. So
- 16 you can take a look at that. And whenever we come back
- 17 to the table to begin our negotiation -- negotiations,
- 18 that language is ready for that.
- 19 The second item on our list was the Indian Housing
- 20 Operating Cost Study, and specifically, this issue came
- 21 down from local area cost adjustments that are in the

- 1 FCAS side of the formula, specifically AEL and FMR.
- 2 And what we're taking a look at is we have a TA
- 3 request based on the operating cost study, and I don't
- 4 know if all of you saw that operating cost study that
- 5 was done in 2008. A very good study that HUD and a
- 6 contractor accomplished, and so we were supposed to
- 7 have done our homework and read the document. And I
- 8 think it's about 135 pages long.
- 9 But the summary of the document really is that it
- 10 makes a request that we add an additional local area
- 11 cost adjustment factor, and that factor comes from the
- 12 515 program under USDA. And so, we are now under a TA
- 13 request asking how that impacts if we added that into
- 14 the formula.
- 15 And HUD, of course, has to go to USDA to re-create
- 16 what was done under the cost study because that old
- 17 data is not usable. So it has to be re-created, the
- 18 new data brought in and put into the funding formula.
- 19 And so, all that is going to take some time, probably
- 20 will not be done by Scottsdale is what we heard today.
- 21 So we're waiting to make a decision from our workgroup

- 1 what we do with this issue.
- We are going to have a summary of the document
- 3 presented to the workgroup and make a decision probably
- 4 in Scottsdale on what we do with this issue. So,
- 5 basically, it's on hold right now.
- 6 Number 3 on our items was Mutual Help unit
- 7 conveyance. We have a subgroup that's meeting on that
- 8 issue. We have some proposed language that they are
- 9 working on, and so that's a big issue for a lot of
- 10 folks, I know. And so, we're working on that issue,
- 11 trying to get some proposed language back to our
- 12 workgroup, probably in the morning, and finalize that
- 13 issue.
- 14 Item Number 4 on our issue was a specific
- 15 regulation that's in the current regulations at
- 16 1000.306(c), which talks about Section 8 units. And I
- 17 think that language specifically says that Section 8
- 18 units will be reduced by the same number of FCAS units
- 19 have been reduced since the implementation of the
- 20 program.
- 21 The problem with that language is it is in

- 1 conflict with Section 502 of the amendments of the
- 2 statute from 2000. And basically, the statutes govern,
- 3 and so the language at the regulation has to go away.
- 4 We're calling that a technical correction, and that
- 5 will be gone.
- 6 We do have another issue that we addressed in the
- 7 HUD guidance on conversion of units, and we are working
- 8 on that new language. The drafting -- our drafting
- 9 committee is meeting this evening for some time and
- 10 coming up with that language. So that will probably be
- 11 ready again in the morning for us to go through and
- 12 fine-tune and get ready for the full committee's
- 13 consideration.
- 14 We had another item on our list of issues as far
- 15 as FCAS, people that get FCAS money with no need or
- 16 very little need. And we have a couple of TA requests
- 17 from our last meeting, and we went through those TA
- 18 requests. And basically, we had a pretty good,
- 19 probably an hour discussion on this issue and, in the
- 20 end, decided that we've looked at the issue. We've
- 21 tried to see if there really was an issue there to come

- 1 up with some proposed language on.
- 2 And then there's also an issue with the statute
- 3 because there is statutory language on what we call the
- 4 1996 "hold harmless" language, which is basically that
- 5 floor that we can't get funded under. And so, that
- 6 really hampers us coming up with any kind of regulatory
- 7 language that affects those recipients of NAHASDA funds
- 8 that are in that situation where they get FCAS money
- 9 with no needs.
- 10 And so, in light of all those issues, we've
- 11 decided that we've studied the issue, and there is no
- 12 issue really to present to the full committee. So the
- 13 issue is done.
- 14 Number 6 on our list was a time limit on grantee
- 15 expenditures. Again, we had a pretty good discussion
- 16 again today about this issue. We are waiting for a TA
- 17 request that had to go through a FOIA process to get
- 18 all of the LOCCS balances that really see what the
- 19 parameters of the issue are.
- 20 We had a good discussion again today on the
- 21 President's budget request language that's out there,

- 1 the congressional appropriations language that's in
- 2 play right now. And so, we are -- in light of all
- 3 that, we have some language that we've passed on to our
- 4 drafting committee that's going to put -- we've kind of
- 5 put some sidebars on the issue, passed the issue on,
- 6 and they're going to draft some language for us. And
- 7 we will be considering that again tomorrow and probably
- 8 have language for the full committee by Friday on that
- 9 issue also.
- 10 Item Number 7 is Section 302(c) of statute. That
- 11 statutory language talks specifically about other areas
- 12 that we can -- we can put in additional factors in the
- 13 formulation of the formula. We had a good discussion
- 14 on this issue, too, on what some of those factors could
- 15 be.
- 16 We talked about maybe it's something that can be
- 17 attained, an incentive kind of factor that would give
- 18 people that perform a little more money. There were
- 19 some folks that felt that that was a good idea, some
- 20 folks felt that it wasn't.
- 21 We had a good discussion on the geographical

- 1 distribution language that is in 302(c) that talks
- 2 about those factors that were administrative factors
- 3 that we need to talk about and discuss. That is
- 4 original statutory language that hasn't had any
- 5 regulatory language behind it since day one, and so
- 6 we've kind of exercised the views again on that issue
- 7 and had a good discussion on it. But we do have a TA
- 8 request because some folks brought up the issue of
- 9 geography and how in some parts of the country where
- 10 you have large geography, maintenance costs are a lot
- 11 higher.
- 12 Granted, there are factors in the formula for
- 13 adjusting those with local cost factors. AEL, FMR are
- 14 currently in the formula. TDC is in the formula for
- 15 the modification side of the formula for that very
- 16 issue. But we were again maybe thinking something
- 17 could be added in here just to help bolster that issue.
- 18 We talked specifically about roads and BIA data
- 19 that could be out there that might give us some
- 20 parameters for that. We had a good discussion on
- 21 infrastructure, on needs and costs and how those

- 1 inflate in rural areas. And so, we are looking at a TA
- 2 request for both BIA and IHS data that could possibly
- 3 help us.
- One way, maybe some possible language under this
- 5 additional factor to be considered. So that one is
- 6 still being worked on.
- 7 Then we did get to Item Number 8 on our list,
- 8 which that item is the HUD process and practices that
- 9 could be in conflict with current practices or the way
- 10 things -- the program is run today. Essentially what
- 11 that means is that if there is a HUD guidance or notice
- 12 that's out there that's governing something that we as
- 13 the recipients on how we conduct our business and it's
- 14 not grounded in regulation, that it should be.
- 15 And so, we had a TA request early on that listed
- 16 out all of the HUD guidances and notices, and we went
- 17 through those this afternoon and determined that other
- 18 than the one I pointed out in our earlier discussion, I
- 19 think we're okay. Nobody at the table really had much
- 20 information or issues that were in conflict.
- 21 We even looked at the IHP and APR form and the

- 1 formula response form because those documents have
- 2 specific language that HUD communicates with you on.
- 3 If there is anything in that that they're saying that
- 4 isn't grounded in regulation, we wanted to make sure
- 5 that that was covered. We didn't find anything.
- 6 So, again, if you weren't in our workgroup and you
- 7 feel like there's a practice happening that isn't
- 8 grounded in regulation, please let us know because that
- 9 could be covered by this issue. But we pretty much
- 10 exhausted the resources in the TA request that we had
- 11 before us on this issue, and so I think we're -- we're
- 12 ready to call that issue studied and closed.
- 13 The last issue -- last, but certainly not least --
- 14 was the issue of NAHASDA units, NAHASDA assisted units.
- 15 And I know there was a lot of folks waiting for us to
- 16 have this discussion because every NegReg, it seems
- 17 like we come to this issue on the formula. And so,
- 18 we've had a very spirited discussion in this issue
- 19 again.
- 20 The kind of the parameters of what we've centered
- 21 the discussion on is how do you define a NAHASDA

- 1 assisted unit? We have asked for if HUD has any way to
- 2 track any kind of number that's out there of how many
- 3 units have been built that could be considered NAHASDA
- 4 assisted, either 100 percent NAHASDA funded or any
- 5 amount of money that's gone into units that have been
- 6 developed that could be called NAHASDA assisted.
- 7 And so, we -- you know, again, lively discussion.
- 8 You know, we did reiterate some of the issues from the
- 9 past as far as, you know, if you have NAHASDA funded
- 10 units, does that just mean that those that have will
- 11 just have more? Will that mean that the needs portion
- 12 of the funding formula goes away because all of the
- 13 money that's left over for needs would go to NAHASDA
- 14 assisted units? So we know that there's a lot of folks
- 15 that have pretty strong feelings on both sides of that
- 16 issue.
- 17 We are -- our discussions aren't complete in this
- 18 area. We've submitted a TA request asking for the
- 19 previous preamble language from previous NegRegs just
- 20 so that we're seeing what previous Negotiated
- 21 Rulemaking Committees have said in this area.

- 1 So then we finished up our discussion today on an
- 2 idea that is just basically a tracking document on
- 3 these nine items so that folks aren't relying on my
- 4 notes or other people's notes within the committee on
- 5 where we're at on these issues. That it's a tracking
- 6 document that says here is what we've done, here is
- 7 what the action stuff we're waiting for, and here is
- 8 where we're headed on this issue. Or if it's done.
- 9 So we -- but I think we made pretty good progress
- 10 today. We're going to make better progress tomorrow in
- 11 finishing some of these items. And some of them we
- 12 could talk for years on. So --
- 13 (Laughter.)
- MR. ADAMS: That's where we're at today. Thank
- 15 you for the opportunity to give a report.
- 16 MS. BRYAN: Thank you, Jason. Very, very
- 17 impressive. Good job on all the work that you guys
- 18 have done. And everybody who sat in the rooms and
- 19 participated, thank you also.
- 20 Next update is from the needs workgroup. We have
- 21 new co-chairs, Gary Cooper and Jack Sawyers.

- 1 MR. COOPER: Thank you. And thank you for -- to
- 2 Jack for agreeing to serve as co-chair.
- I don't know that we got anywhere close to where
- 4 Jason got, but we got a good start. We started out the
- 5 morning with, of course, Sami Jo, thank you for her
- 6 service to the committee -- or to the workgroup. Got
- 7 some pretty big shoes to fill, but I'll try and do my
- 8 best.
- 9 But also Sami Jo had submitted a TA request before
- 10 for Susan and Ben to help our group out just a little
- 11 bit, and so they started that today. It was really
- 12 good. It was a big help, and it was really beneficial
- 13 to us.
- 14 Susan handled some of the parts of the
- 15 presentation, and then Ben is also there for -- to help
- 16 provide us some technical assistance or technical
- 17 advice on different matters, which is really good.
- 18 This morning, we started out with the Census
- 19 presentation here in this room. I think the room was
- 20 pretty full. There was a lot of people here. So a lot
- 21 of people got to see what -- see the presentation by

- 1 Census. We have also asked them -- and if they're
- done, there are copies outside. They're going to have
- 3 those out on the tables later on. But they'll also be
- 4 posted up on the Web site.
- 5 There was a slide presentation. There's some
- 6 supporting documents that go along with that. And I
- 7 believe also on there, they're going to list out the
- 8 Web site or the link to their Web site where some folks
- 9 had some questions about where some of the backup is
- 10 coming from some of the information they used. So
- 11 that'll be able to explain a little bit of that.
- 12 Mr. Treat with the ACS was here, who is with the
- 13 Census, and then several of the staff members. So we
- 14 had a good presentation on that. I would suggest that
- 15 if anyone has -- that folks do stop by and pick up
- 16 those slides if they would. I think there's a lot of
- 17 good information in there that may be pretty handy to
- 18 folks.
- 19 After that, we broke for lunch and then went back
- 20 into our regular workgroups. We meet upstairs in
- 21 between the two levels in the Columbine Room. We

- 1 worked out and discussed quite a few things.
- 2 One of the things that we did do is we are working
- 3 on preparing a sub-workgroup, I guess we might call it,
- 4 for the workgroup we have. They're going to meet
- 5 tonight at 7:00 upstairs, again in the room we were in
- 6 to discuss some things related to that situation, the
- 7 information that we had had to discuss and agree to a
- 8 concept from at the last meeting.
- 9 There was a couple of documents also prepared and
- 10 brought forward that had some good information on it.
- 11 So I think that several people have agreed to meet late
- 12 this evening to go through and work out those and then
- 13 bring them back to the committee tomorrow so we can
- 14 help -- kind of go from there and also help establish
- 15 the parameters for the subgroup or sub-workgroup or
- 16 whatever we're going to decide on calling it.
- 17 So that will take place at 7:00 this evening. And
- 18 they'll work on fine-tuning the details to that
- 19 document and bring back to the workgroup tomorrow.
- 20 Also we were really close on having some language
- 21 prepared and brought back here this evening. We didn't

- 1 quite make it, but we do have some language that was
- 2 prepared by the drafting committee, and we should be
- able to hopefully bring that back to the committee
- 4 tomorrow. Some workgroup members had asked for some
- 5 additional time to review it.
- 6 In the end, that all goes back to the concept that
- 7 was agreed to back last month at Scottsdale. And that
- 9 which would be the data source. The data source, also
- 10 the study group, the volatility factor, a portion of
- 11 that, and the whole -- implementing the language for
- 12 the concept that everyone agreed to last time.
- 13 So, with that, I think that is pretty much where
- 14 we got to today. It doesn't sound like a whole lot,
- 15 but it was the beginning of some pretty big, pretty
- 16 major issues, which I think once we can kind of get
- 17 these two things moving forward, that we'll be able to
- 18 maybe knock out some other things.
- 19 So at least we're making good progress. Thanks
- 20 for all of the folks who participated in our meetings.
- 21 I think everyone there had -- played a large part in

- 1 our -- in our discussions, and we certainly appreciate
- 2 that. I think our room was pretty close to being full.
- 3 I think they had to bring us some extra chairs.
- 4 So thank everyone for coming, and with that,
- 5 that's all I have unless anyone has any questions.
- 6 MS. BRYAN: Thank you, Gary. Are there any
- 7 questions for Jason or Gary? Jack?
- 8 MR. SAWYERS: We are going to ask for a caucus
- 9 tomorrow in connection with our study. It shouldn't be
- 10 a very long one, but we will ask for a caucus in the
- 11 morning.
- 12 MS. BRYAN: In the morning, okay. Thank you. You
- 13 try and remember, and I'll try and remember. And if
- 14 not, someone remind us.
- 15 Any other questions?
- 16 (No response.)
- MS. BRYAN: Yeah, again, thank you for all the
- 18 hard work. It was a lot of progress, and that feels
- 19 really good.
- 20 Part of what we do here at these Negotiated
- 21 Rulemaking Committee meetings is open it up for public

- 1 comment. So at this time, it is 5:26 p.m., and I would
- 2 like to open up public comment for Session 5 of
- 3 negotiated rulemaking.
- 4 It looks like there's a microphone on either side
- 5 of the room. So those of you in the public are welcome
- 6 to come up and give any kind of comments or feedback.
- 7 That will go into the public record for this session.
- 8 (No response.)
- 9 MS. BRYAN: At the end of each working day, we
- 10 will have an opportunity for public comment. So if
- 11 you're really itching to say something, we will open it
- 12 up again for you tomorrow after the meeting. And want
- 13 to thank all of the public for coming and attending the
- 14 workgroup meetings, as well as HUD and the members of
- 15 the committee.
- We are going to close for dinner. The workgroup
- 17 rooms will be available and open for those of you who
- 18 are getting together for the later meetings to
- 19 accomplish different tasks that you guys have set up
- 20 for yourselves.
- 21 And at this time, I would like to close. And

- 1 we've asked Jason Adams from this region to offer a
- 2 closing prayer today.
- 3 MR. ADAMS: Join with me in a word of prayer this
- 4 afternoon.
- 5 Father God, we thank you once again for this
- 6 opportunity to gather. We thank you for your provision
- 7 and all that you provide for us. We thank you for our
- 8 families back home and those that rely on the work that
- 9 is done here.
- 10 I thank you for each and every person here that's
- 11 come with items to be discussed and issues to be
- 12 addressed because we are all here to take care of those
- 13 back home and that we remember those today, our
- 14 families and our friends and our relatives, our elders
- 15 especially. Those that have taught us and passed on to
- 16 us over the years those things that are important to
- 17 us.
- 18 First and foremost is you and our acknowledgment
- 19 of you. As my dad always reminds me, we, as Indian
- 20 people, never fought over who Creator was. We thank
- 21 you for guiding us and showing us what your will is

- We thank you that we have the opportunity to be
- 3 here to speak for those that can't speak for
- 4 themselves, for our elders, those that have great
- 5 needs. We thank you for our children and the
- 6 generations to come, those that we have the awesome
- 7 responsibility to make sure that they're provided for.
- 8 And we thank you that we have the opportunity to
- 9 see them grow, to continue on with what we've been
- 10 taught, what we learned and what we pass on.
- 11 For all these things, Lord, I thank you. In
- 12 Jesus' name I pray, amen.
- MS. BRYAN: Thank you. And with that, we'll
- 14 recess, and we'll see you in the morning at 8:30.
- 15 (Whereupon, at 5:30 p.m., the meeting was
- 16 adjourned.)
